I DO NOT want an extension to the Emergency bill.

I DO NOT support the Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Bill 2022 (Bill), which will allow the State of Emergency in Queensland to be extended until 31 October 2022.

My reasons are:

The government overreach for loss of jobs, income and family due to mandates and restrictions has gone on long enough. With absolutely no data to back up their decisions.

Certified Data

According to the latest figures from the COVID-19 Mortality in Australia | Australian Bureau of Statistics (abs.gov.au) (January 2022) there has been a gross exaggeration of the Covid19 data on death reports.

The data states that 273,901 Australians died between March 2020 until the end of January 2022 .

Of these, only 0.9% actually had Covid19

There were 2,639 Covid19 related deaths in this period.

In the same period;

100,000 Australians died from cancer.

32,000 Australians died from heart disease.

30,000 Australians died from Alzheimers and dementia.

10,000 Australians died from diabetes.

The average annual number of deaths due to influenza and pneumonia between 2015 - 2019 was 2,908.

The median age of death of those who died of Covid19 was 81 for men and 86 for women. Both are above our National life expectancy.

92% of the 2,639 Covid19 related deaths had other underlying health issues; an average of roughly 3 diseases or conditions per person. These conditions ranged from pneumonia to kidney infection right up to the biggest risk factor of all – heart health.

In December 2021, a judge ordered Pfizer to release documents concerning adverse events from their Covid19 “vaccine,” which Pfizer fought to have concealed for 55 years. The very first release of 500 documents contained information entitled, “Cumulative Analysis of Post-Authorisation Adverse Event Reports.” The document revealed that within 90 days after the Emergency Use Authorisation release of Pfizer’s mRNA vaccine, the company was already aware of voluntary adverse reaction reports that revealed 1,223 deaths and a total of 158,000 adverse reactions. And yet, despite this information being released, the government and mainstream media were silent, neglecting to report these findings and continuing to peddle Covid19 “vaccination” as “safe and effective” and the only way out of this pandemic. The lack of questions asked in the mainstream media to politicians shows this was not a State of Emergency, only a state of tyranny.

Children are now the target of these experimental injections, despite an extremely low Covid19 Fatality Rate (CFR). As at 3 March 2022\*, in the 0-9 age group, there has been 209,996 cases of Covid19 reported. Of this age group, 4 deaths from Covid19 have been reported. That is a CFR of .002%. And yet our government and media continue to propagate that Covid19 vaccination of children is safe and effective. More effective than a .002% fatality rate? Innocent children with their futures ahead of them are being injected with an experimental and potentially harmful – if not lethal – toxin, with no long-term safety data and little to NO efficacy.
