SUBMISSION TO QUEENSLAND PARLIAMENTARY COMMITTEE

RE: PUBLIC HEALTH AND OTHER LEGISLATION (EXTENSION OF EXPIRING PROVISIONS) AMENDMENT BILL 2022.

Dear Members of the Queensland Parliamentary Committee,

I wish to make it known that I do not agree with the proposed extension of The Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Bill 2022.

There is insufficient justification for the restrictions on the communities' freedoms to be extended beyond April 30<sup>th</sup> 2022.

My basis for this statement is evidenced below.

1. The ABS (Australian Bureau of statistics) released new data on the 15th Feb 2022. This data covered 22 months of COVID -19 (March 2020 - 31st Jan 2022) and specifically focussed on the mortality rate.

- Over that 22 month period, there were only 2556 deaths directly related to Covid -19 yet the total number of deaths for the same period was 273,901.
- This accounts for fewer than 1% (0.93%) of the entire Australian population having died as a direct result of Covid -19.
- Of the 0.93% people that died, 91.4% had underlying health issues and these were listed as a cause of death alongside Covid- 19.
- The median age of Covid- 19 related deaths was 83.7 Yrs (81.2yrs- Male/86yrs- Female). However the average life expectancy for all Australians is 81.2 years

for Males and 85.3 years for females. This highlights that the Covid-19 related deaths did not shorten the expected life span of the deceased persons.

- During that same period of time (22 months) over 100,000 people died of Cancer, 32,000+ people died from Heart Disease, 30,000+ died from Alzheimer's/Dementia and 10,000+ from Diabetes.
- During the entire time of this event, the Qld CHO did not suggest living a healthy lifestyle such as exercise and eating healthy to combat obesity, heart disease, diabetes to lower the possibility of death from Covid -19 due to these health conditions. Yet during every media statement the number of people that died of or with Covid -19 with underlying health conditions was mentioned.

2. On the 1<sup>st</sup> March 2022, Pfizer released its clinical trial data for its Covid -19 vaccine safety to the public due to a court order. This data only covered the period from 1<sup>st</sup> December 2020 to 28 February 2021 (13 weeks).

- During that period (13 weeks) there were 42,086 reports of adverse events related to their vaccine.
- It is noted in this report that the vaccine can give a person Covid -19 and they can also become carriers of the virus after vaccination and spread to others within the community.
- The data shows that the adverse events listed as a result of vaccination affect females more than males.
- Pregnant women vaccinated during this period saw various complications such as death of the foetus, spontaneous abortion, premature birth yet this vaccine is actively promoted as safe for pregnant women.
- Suppressed lactation occurred in breastfeeding women along with other complications such as vomiting, Paresis (partial paralysis ) and breast milk discolouration.
- Babies exposed to the vaccine via breast milk were noted to have clinical adverse events such as vomiting, rash, hives, fevers, diarrhoea, and allergy to the vaccine.

- Of particular concern is the long list (8 pages) starting on Page 30 of Adverse Events of Special Interest. This list contains life changing diseases and illness that have shown up during the clinical trials. Neurological events such as Demyelination, Myelitis, Epilepsy, Encephalopathy, Guillian-Barre Syndrome accounted for 1.2% of the database. Autoimmune diseases, cardiac problems, cancer causing syndromes, many different types of herpes related diseases, Renal failure, Liver Injury, Chrohns disease, Stevens- Johnson syndrome, kawaski disease, Hasimoto's disease are just a few of the many debilitating diseases noted as a result of vaccination over just 13 weeks.
- The data clearly shows that the vaccines are not "Safe and Effective" as stated by the CHO so vaccinations should not be mandated and vaccination mandates for Covid – 19 should be ceased immediately.
- There is no data for reproduction and fertility issues as this will take several years to collect. Yet it is now being "Pushed" onto children from as young as five yrs old when there is no clinical evidence to suggest that they are susceptible to Covid-19 and safety data for reproduction and fertility is years away.

3. The proposed bill violates many rights and liberties of individuals in the name of Health and Safety and also breaches several Fundamental Legislative principles as mention on pg 11 of the explanatory notes for the Bill.

- The Bill allows the sharing of confidential information which breaches the Privacy act and Unesco (Universal Declaration on Bioethics and Human Rights)
- The bill states that it encourages compliance by providing penalties. This breaches many different laws and Legislation such as Legislative Standards Act 1997 Sect4(2)(a) Legislation has sufficient regard to the rights and liberties of individuals.
- The bill is reminiscent of the "White Australia" policy of years ago that segregated individuals based on race. This bill now segregates people based on health in particular a "Green Tick". It has removed the rights of individuals to travel freely, work without discrimination, and removed their rights to enter a building based on a Vaccination passport.

- This bill does not support health such as exercise and healthy eating to reduce the risk of underlying health condition instead it relies on segregation, and discrimination and fear similar to Nazi Germany however instead of “show me your papers” it has been replaced with “show me your vaccination pass”.
- The bill states that these actions are justified in order to protect the health, safety and welfare of Queenslanders. However there is no proof that these measures have resulted in achieving this outcome. Vaccinated people are still contracting and dying from Covid-19 which shows clearly that these measures are not working.
- The welfare of individuals has not been addressed at all in this Bill with many businesses closing, staff unable to work, people losing their careers due to vaccination mandates causing undue financial stress with many unable to obtain assistance in the form of Job Keeper/Jobseeker, losing their homes and livelihoods. Families unable to see dying loved ones even though they have been vaccinated just because they resided interstate, cancelled weddings and celebrations.
- There is no evidence to suggest that wearing a mask stops the spread of covid-19 and many studies to prove that it causes respiratory problems. Watching many people at the supermarket would suggest that it actually spreads the virus as people continually touch their masks and then items on shelf and fresh produce.
- Many children have now become fearful of people not wearing a mask which is not in keeping with the statement within the Bill that it is for the protection of Queenslanders welfare. If anything it is contributing to mental health problems in children.
- Also noted is the justification for the extension is that it is to protect Queenslanders from a spike over Winter. There is no evidence to justify this statement and the UK is now coming out of their winter with no major spikes in deaths. It has remained reasonably stable and they have a lower vaccination rate. In 2 weeks they are also removing vaccination mandates. They are moving forward yet we are dragging the chain. Overseas travellers will not

come to Australia while we still have restrictions in place when other countries do not.

- This week's floods have highlighted the problems of vaccination mandates. The mandates have resulted in people not being able to help in the SES and Mud Army due to their vaccination status. This week's floods are a more pressing emergency and a vaccine will not help you when you are drowning or losing a lifetime of memories and belonging.
- The measures put in place make no sense in relation to stopping the spread of Covid- 19. You cannot go to a coffee shop and sit and eat if unvaccinated yet you can sit and eat in a food court. You cannot go to a pub or club to drink and socialise if unvaccinated yet can buy alcohol and have a large gathering in your house. These measures are not designed to stop the spread of the virus they are solely designed to discriminate and segregate.
- Since the vaccination mandate started on December 17 there has been a significant increase in Covid cases and deaths. However the unvaccinated rate has fallen to just 9.2% yet over 530,000 new Covid cases have been recorded. Another sign that the Emergency powers are not working or needed.

In conclusion, there is absolutely no reason to extend these Emergency Powers. Queensland is now over 90% double vaccinated with many now getting their booster yet people are still dying from Covid-19. The emergency powers have not stopped the rapid spread of Omicron nor have the vaccination mandates or masks. People were told by the CHO to get vaccinated and you would be protected yet these same people are still dying from Covid- 19. People were told by Ministers to get vaccinated as the virus hunts down the unvaccinated, then they were told by Ministers that the virus hunts down those that hadn't had their booster. These Ministers are using this Bill to instil fear and segregation. They are not using it for its intended purpose of protection of Queenslanders they are using it to control.

By not extending this Bill the bullying and fear tactics displayed by Ministers will end, the segregation and discrimination will stop and rights and liberties of

Queenslanders will be restored. I thank you for your time in reading my submission and trust my evidence and thoughts will be considered
