Dear Committee - To Whom It May Concern:

I strongly object to any Extension of the Emergency Bill.

There has never been a true public health emergency.

The ABS data clearly shows that there has never been significant excess mortality (until the COVID 'vaccines' were introduced, that is), or that the average age at death dropped significantly.

Further analysis revealed that the death figures attributed to 'COVID19' were massively inflated and exaggerated. More than 90% of the people who supposedly died from 'COVID19' had significant and life-threatening co-morbidities AND had reached or surpassed their statistical life-expectancy.

Aside from that, Influenza-related death numbers in previous years had been significantly higher.

Furthermore, 'case' numbers were and are being massively inflated by mass screening the public with imprecise tests that have extremely low positive predictive values when used without a proper clinical context. Basic bio-statistical methods can easily prove that most of the so called 'cases' obtained with such methods are false positives. The PCR method was never intended and is not suitable to be used as a diagnostic tool to detect clinically relevant infectious disease and contagiousness, in particular not when used with high cycle numbers.

In addition, asymptomatic spreading has never been conclusively proven to exist or play a significant role in the spreading of any infectious disease.

At no point during this pseudo-pandemic has our hospital system been overwhelmed, and where problematic situations arose, they were mostly created by needless, useless and inappropriate 'public health directives'.

None of the endless public health directions issued under the pretence of a 'public health emergency' (lockdowns, social distancing, mandatory masking, mandatory vaccinations etc) had or have ever been proven to significantly reduce 'case' numbers or transmission, and recent analyses published by the Johns Hopkins showed that the

effect of those measures was at best 2% reduction - whilst causing almost immeasurable economic, social, physiological, emotional, and psychological damage to our society and individuals. Furthermore, most of those health directives were and are violations of the Federal Bio Security Act 2015.

In summary: There has never been a true reason for the declaration of a 'public health emergency', and the continued extension of such a state, in particular without defining any clear exit criteria, can only be seen as an unconstitutional and criminal totalitarian attempt to more and more abolish democratic and rule-of-law principles.
