Dear Committee Secretariat,

The Community Support and Services Committee has invited submissions from all interested parties, addressing any aspect of the Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Bill 2022 being extended until October 2022.

I write to express my strenuous opposition to extending the expiring provisions even one day further let alone another 6 months. I opposed the previous extension, and there is less reason to justify it now, and more evidence mounting to reject this action. There was little time to prepare a full response so this letter will suffice.

- The crisis is over
- Sars Covid 2 has never been isolated
- The PCR is not fit for purpose. Its emergency usage authority was revoked in July to be phased out by December 31. 2021
- There was a pandemic of positive tests, not cases
- Data has been manipulated and misleading
- Quarantine is to separate infectious individuals, not the whole population
- Government claims to uphold Human Rights, yet have contravened the Human Rights of untold numbers of people in various ways
- This parliament is a corporate business, not a government and is not operating under the Queensland Constitution Act 1867.
- All emergency measures have created far more damage than a cold or flu could inflict. If they are to continue, it will become more obvious to more of the population there appears to be a wilful disregard for the value of human life and businesses.

There have been FOI requests from more than 80 countries, where authorities admit Sars Covid 2 cannot be isolated, therefore this entire crisis has been manufactured and more people are becoming aware. With each booster needle being bullied, coerced, enticed or enforced, more and more people become aware that have been duped.

The PCR test, as our Premier would be aware, was never intended to detect infection, or variants. In fact, as testing increases, and inoculation increases, so do cases. In countries with low vaccination rates, and where they used safe, effective drugs, there were very few

cases detected. The PCR test has been used at over 40 cycles, unless it is used on vaccinated people, in which case it is under 25 cycles so as to avoid finding positive cases.

There is mounting evidence that there are more hospitalisations and deaths corresponding with vaccination rates.

The more people get tested, the more cases, and the CDC and FDA in USA have admitted the vast majority, over 80% of original cases were false positives and this is little worse than a flu season.

An average flu season in Australia kills 1500 people, and up to 3000 in a bad season.

There is no proportional response and the rights of too many people have been trampled.

Quarantine is a period of time – 40 days on ships originally – to prevent spread of contagion or infection, and was only ever applied to infectious individuals, not an entire population. If health and real doctors were permitted to do their job, the sick and vulnerable would be isolated and treated, leaving the rest of the population to carry on their daily routine. Doctors would be encouraging patients to eat well, get fresh air and exercise not to cover their faces, stay indoors and watch the TV. Doctors would be permitted to prescribe longtime proven safe, cheap and effective medication which had no reason to be unlawfully banned, other than more profits for pharmaceuticals, investors, DNA labs and their many shareholders.

This is not about health. The double standards displayed have shown that one rule applies for some while other privileged personnel can do as they wish. More people have lost their lives due to suicide, rise in preventable diseases and lack of detection and treatment due to hospital chaos, decline in mental health and rise in cases of depression, separation and other conditions.

The Provisions unlawfully applied to the Public Health Act gave extraordinary powers to an unelected bureaucrat to impose penalties on Queenslanders for an artificial health crisis, and an extension of powers cannot guarantee it will never happen again. Few times, if ever has a government returned the power given to itself back to the people.

As a real living woman, I am not subject to laws made relating to persons, citizens and individuals, and as more sovereign individuals become aware that the government has abused their position of power, more will assert their sovereignty.

No, I do not and cannot support this bill.
