**RE: PUBLIC HEALTH AND OTHER LEGISLATION (EXTENSION OF EXPIRING PROVISIONS) AMENDMENT BILL 2022 (BILL)**

This letter serves to formally advise that I **do not** support the Bill nor the extension of the state of emergency.

The past two years have seen tens of thousands of Australians suffer tremendously under the mandates that were enforced on the people under the current Emergency bill and demonstrates a further extreme overreach by Queensland's current sitting government.

The COVID pandemic is over. Countries around the world have dropped their mandates and restrictions and are beginning to move on and learn to live with COVID. Why then, the Queensland government feel the need to further extend their Emergency bill further is beyond me.

The Queensland government is beyond out of touch with its community, and the impact that these mandates enforced under the Emergency Bill have had on; families, small-medium businesses, our children and the greater community at large. This Bill needs to be put to bed for good and the State of Emergency concluded.

**GOVERNMENT CONTROLS ARE PERPETUATING MORE HARM THAN GOOD**

- Entire communities have been divided by propaganda being spread by the government relating to those who received the COVID medical experiment versus those who did not.
- Tens of thousands of people lost their jobs for choosing bodily autonomy over coerced vaccination.
- Children missed endless days of school due to closures and teacher shortages.
- Families have suffered loss after loss; financially, emotionally and physically.
- The greater community has seen a dramatic rise in demand for mental health services as a direct result of the psychological impacts of; regular isolation, fear-driven indoctrination, and the endless unpredictable nature of when the government will reintroduce mandates that continue to disrupt the peoples' everyday lives (REF 1).

Despite all of the aforementioned issues perpetuated by the Governments nonsensical mandates, Australia at large has seen Queenslanders begin to reunite in peaceful protests to communicate its displeasure with said

Emergency powers and restrictions. These protests however, have continued to fall on deaf ears and ultimately Queensland much like the rest of Australia is seeing the beginnings of a growing distrust in its public institutions.

### **OVERPREDICTIVE MODELLING & EFFECTIVE TREATMENT NOT APPROPRIATELY CONSIDERED**

The original Emergency Bill was granted on 29 January 2020 based solely on modelling for the Alpha and Delta variant death rates seen globally. We know now that the TGA and CDC have admitted that only 8.6% and 6% respectively, of COVID-19 deaths could be solely attributed to the virus (REF4.5)

- Healthy individuals are not at high risk of complications from SARS-COV-2 if they catch it.
- You can naturally boost your immune system to lessen symptoms outside of vaccination.
- If you catch the virus there are alternate safe and effective treatment protocols to aid in recovery which have been used by doctors in other countries around the world since March 2020 and do not require vaccination.
- The predicted and reported severity of the disease has been grossly overestimated.
- Natural immunity gives longer-lasting protection against reinfection and holds far less risk than vaccination.

Knowing this, there is absolutely zero justification to extend the Emergency Bill, particularly after witnessing the endless discriminating and terrorisation of our state and its people over the last two years. It is clear the Emergency Bill is now less about managing a 'healthy crisis' and more about retaining the powers and control gained over Queenslanders indefinitely.

### **AUSTRALIAN BUREAU STATICS GIVES PERSPECTIVE ON THE SEVERITY OF SARS-COV-2**

Data demonstrate the following;

From March 2020 until the end of January 2022;

- 273,901 Australians have died..
- 0.9% had COVID-19
- That's a mere 2,639 COVID-related deaths.

Within the same period, roughly;

- 100,000 Australians died of Cancer
- 30,000 died from heart disease
- 30,000 died with Alzheimers and Dementia
- 10,000 died from Diabetes

In addition to the above, the less than 1% of COVID deaths median age range was 81 for men and 86 for women. Both of these ages are above our national life expectancy. So why the extreme measures for a disease that has seemingly mutated to be as insignificant as the flu. Why do we need to extend any emergency powers for a disease most Australians have survived and gained natural immunity for? Why enforce vaccination on those in particular workplaces (including those that don't deal directly with the public) when it has never been a requirement in all of our history? We have never before seen a mandatory experimental drug being coerced on those suffering from Cancer. We have not seen the government enforce restrictions on those who choose to live an unhealthy lifestyle that will likely lead to heart disease or diabetes. So why, is COVID being demonized and used to instill fear in the worldwide population? Ask yourself why.

**VACCINES HAVE HARMED AND DISABLED FAR TOO MANY AUSTRALIANS**

Initial claims by Government were that mass vaccination (first and second dose) to first reach 70% and then 90% of Queenslanders, would be our ticket out of this pandemic and that we would return to life as normal. Why is it then that over one year after vaccine rollouts commence and having already achieved those targets, Queenslanders are now being coerced into a third and some even a fourth “booster” to maintain employment or be able to participate in society as we once did pre-pandemic? The Government has time and time repeated that it is not forcing mandatory vaccination on its people, yet people are being coerced to make a decision of one or the other. Many are choosing vaccination simply because they need to work or want to remain free citizens of our country. According to Merriam-Webster; “Freedom is the absence of necessity, coercion, or constraint in choice or action”. That being said, the choice to get vaccinated has and never will be a ‘free’ choice for Queenslanders until the restrictions imposed for choosing not to comply are revoked. This is just another reason to expire the Emergency Bill and allow people to choose *freely* how they wish to live their lives.

Outside of the coercion, there has been no clearly defined benefits for a vast portion of the population to be inoculated, nor is there any data for the long-term risks of these experimental therapies that are only being used in humans because of the state of emergency.

Even more concerning, Pfizer has been court ordered to release the entirety of its medical trial data which demonstrate the enormity of the risk being imposed on the Queensland population after listing 9 pages FULL of adverse events and reactions encountered during trial phases. Outside of the State of Emergency this data could not be ignored by ANY democratic government but apparently under the Emergency Bill, all reason has been suspended, and governments have been given an unsurmountable level of power in which they are able to coerce their own people into repeatedly taking part in this dangerous, toxic and ineffective experiment. The Emergency Bill has to cease, immediately!

**REJECT THE BILL AND EXTENSION OF STATE OF EMERGENCY**

It is beyond clear to the people of Queensland and Australia at large, that we have been lied to. We have been coerced and discriminated against, all in the name of ‘public health’. The only way this has been made possible is due to the continued extension of the State of emergency. The people have suffered enough at the hands of unlawful and unjust government mandates and the time to make a difference is now!

If the peoples requests for the cessation of such powers continues to be ignored, then it begs to ask the question, are we still even a democracy or is this just the beginnings of a corrupt, authoritarian dictatorship.
