To Whom it May Concern,

I am extremely opposed to the extending of the current Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Bill 2022.

The proposed extension of the Bill was to increase powers of emergency officers and the Chief Health Officer to respond to the spread of "covid 19" in Queensland, support testing and quarantine requirements;

Can you please provide me with the evidence that Queensland is still, or was ever, in a state of emergency?

With mandates being withdrawn all over the country and even with our cousins in New Zealand, there is no reason what so ever this Bill should be extended any further to the 31<sup>st</sup> of October 2022.

The people of Queensland have been punished enough! Even those that are "fully vaccinated". For the community that have refused the "covid vaccines" and have therefore struggled mentally every day for at least the past 6 months, this HAS to stop.

Prior to "covid" taking the front seat throughout the world's media outlets, Queensland's focus was always on DV, juvenile crime and mental health issues. I am a Police Officer for the QPS and have been as at April 2022 for 14 years. The Qld Government has demanded that I cease work immediately and to not return – due to my medical choices. I have not been permitted to work since the 11<sup>th</sup> of October 2021. As you would be well aware, there are currently in excess of about 100 of us in that same boat. Just imagine how much help over 100 Police Officers could do in regards to the current Qld floods and the clean ups.

Within my 14 year career, I have played a major part in two floods within Queensland where I coordinated residential evacuations, which included an aged care residential business and I have also worked closely with the Army – I was tasked to take flight in a helicopter to assess the flood waters within the Roma district and assist with emergency needs of those on properties that had been cut off due to flood waters.

I believe I have extensive flood emergency skills that could have been utilised in the past few weeks..... but no – I have not given consent for a Dr to inject me with a poison which no one has any idea what is in it, but is causing extensive injury to innocent people who have given consent! This is something that informed consent can not be given as there is no data provided in regards to how the average person will be effected. Although, we WILL have that data in 75, or is it now 74 years now?? My choices should not have consequences of taking my career from me! My choices should not have the consequences that my freedoms been taken from me!

The bottom line is that, Queensland is currently NOT in a state of emergency and this Bill need not be extended. There is no justification for it at all. The people of Queensland have spoken – about time you listened and stop the Queensland apartheid.

Do the right thing for Queenslanders now!
