On the 16th June 2021 Minister for Health Yvette D'ath table a bill for the extension of emergency powers past the expiry date of the current already extended date of the 27th September 2021 to the 30th April 2022. This effectively will take Queensland to over 2 years being governed under such an order. Ms D'ath stated that the bill would be referred to the Health and Environment Committee for review, however contrary to her representation, it has instead been referred to the Economic and Governance Committee, even though the "emergency" is of a health nature. The following are my views for consideration:

- 1. The pandemic is over, indeed it was not even a real pandemic like the Spanish Influenza with a cart coming past collecting bodies each day, yes, people had a bad flu, sadly some people died (like they always do with bad flus), but the average age of death from COVID is 82yrs of age, the same age as the average life expectancy thus there is no impact to the average life expectancy, thus there is no pandemic. There is no basis on which "living with COVID" can justify the extension of the SOE powers. The SOE powers are temporrary two years is NOT temporary....any extension is a clear abuse of Govt power. 80% or so of Queenslanders are sick and tired of this nanny state Govt being in our face every day, piss off and get out of our lives. Politicians and Public Servants are servants of the people, we are not your servants remember that.
- 2. My parents are shocked at the reckless waste of money by Federal and State Governments on this COVID nonsense, they do not want to see the country young folk having to repay debt for the next 20yrs, they would rather take the risk (which is their choice, not Govts) than destroy their childrens and grandchildrens futures, unfortunatley it is almost to late as the Qld Govt has already accumlated so much debt with COVID. This was due to the total failure of politicians to lead, instead they delegated their responsibility to Health Officials rather than listen to the health advice, and listen to the other Departmental advice and make a decision based on the entireity of information this was readily visible in all the media conferences.

- 4. - 6. Words politicians will never state, but in reality, that is how at least 50% of the public see it. You need to remember, at least 60% or so of the vaccinated have been coerced i.e. if you want to keep your job, you have to get a jab most of my vaccinated mates are utterly angry and pissed off with the Qld Govt for its mandates one of my mates now has a permenent heart condition that will likely see him dead in the next 5 years due to his "booster" shot (started right away) safe and effective, not for him!!!! In Bundaberg which is a marginal seat (13 votes last election), this seat will be lost.
- 7. In a 55,000-page set of documents released on Tuesday, the U.S. Food and Drug Administration's (FDA's) Center for Biologics Evaluation and Research (CBER) is for the first time allowing the public to access data Pfizer submitted to FDA from its clinical trials in support of a COVID-19 vaccine license. (see <u>CHD Says Pfizer and FDA Dropped Data Bombshell on COVID Vaccine Consumers (yahoo.com)</u>) A 38-page report included in the documents features an Appendix, "LIST OF ADVERSE EVENTS OF SPECIAL INTEREST," that lists 1,291 different adverse events following vaccination. Do you know that no one in Australia who has the Pfizer vaccine was told about these adverse events, thus no informed consent was given. Qld Govt now know this, yet they keep posting on social media, go get your vaccine, go get your booster you are now liable, criminally if someone dies. I have no doubt Qld Govt will be taken to court for its negligence in these issues.
- 8. Other states in Australia have dumped all restrictions including segregation and not extended their powers (you can always request them again in future for something else if so needed), other countries have also dumped their powers and all restrictions the damage done to Qld is immense, no more, money doesn't fall off trees.
- 9. In summary I would reccomend you do NOT extend the SOE Powers, stop asking for people to get vaccinated or boosted for what is a snotty nose, mild flu, stop letting bureaucrats run the state and start leading. Look after all the vaccine injured, unmuzzle the doctors, and make sure a collassal stuff up like the last two years never occurs again.
