To the Committee Secretary,

I am formally advising the Community Support and Services Committee that Shane Chase and Tracey Chase do not support the extension of the state of emergency or the Public Health and other Legislation requesting an extension from the 30th April 2022 until 31st October 2022 Amendment Bill of 2022.

The extension of powers is based on Covid deaths and Covid numbers in Queensland. The Australia Bureau of Statistics data is showing a large exaggeration of the covid related deaths as shown below. This is a false justification of requiring an extension of the State Emergency powers. The Australia Bureau of Statistics data state for the 898 people who died from COVID-19 in 2020:

- COVID-19 was the 38th leading cause of death.
- Their median age at death was 86 years.
- Just over half were female (460 female deaths, 438 male deaths).
- People who died from the virus under the age of 70 were more likely to be male.
- Dementia was the most common pre-existing condition (275 deaths).
- Chronic cardiac conditions, hypertension and diabetes were also commonly reported comorbidities.

The current Public Health Act safeguards, require that the Chief Health Officer (CHO) is to cancel any public health direction as reasonably practicable after the CHO is satisfied the direction is not necessary for containment, or responding to, the spread of COVID-19. This is relevant now as herd immunity has passed through the community and Omicron is a very mild flu like symptoms. Therefore, the CHO is required to revoke this power and reframe from restricting the liberties of citizens. The containment of Covid-19 is not required any further and therefore no rights should be enforced in removing or impeaching on the liberties of any citizens. To extend these powers would be a corruption of power because there is no longer a health emergency and is not necessary.

The Governments stringent controls have not proven to enhance improved outcomes, it has been the opposite. The measures taken by the Government has damaged peoples lives, livelihoods, closed businesses, increased the suicide rate, increased mental health, created discrimination and segregation in community causing insurmountable damage.

The Government CHO (Janet Young) was televised stating face masked don't work and there are also a significant about of papers written by scientist to also confirm this, identifying how harmful masks are. I would also like to bring to your attention that Ivermectin was taken off the shelves in Australia by the TGA at the time of the Covid-19 outbreak so the vaccines could be enforced, because when there is a successful treatment for Covid-19 then vaccines could not be enforced. Now that the pandemic is over Ivermectin has been released again. Australians have a right to know why and how TGA have the power to do this, silencing safe and effective treatments. Also, why when vaccines are only a trial, were mandated with insurmountable evidence that the vaccines, did not reduce the spread of the virus, nor prevent any person from catching it. This continues to be the case and yet Government continues to enforce mandates for something that has failed. Mandates have now been lifted in the United Kingdom and in Canada. There is no further reason to enforce mandates and a review is called for immediately to follow suit with results from other countries leading the way.

The handling of this pandemic has seen the demise of businesses, the education system, the health system, and the many individuals mental and physical well-being. The vaccinations records of injuries on the TGA injury notification lodgements have been unbelievably high. There has been a substantial increase in cardiac related vaccine injuries including too extremely rare conditions, Myocarditis and Pericarditis (particularly in young healthy men).

According to your bill there has only been 399 deaths in relation to Covid. This does not justify an extension of the state emergency powers and I write this letter to strongly reject this bill and any further abuse of powers. Please cease this state of emergency extension request and allow all Australians citizens to take back control of their lives that has been unnecessarily taken from them.
