The Queensland Family and Child Commission (QFCC) welcomes the opportunity to provide a submission to the Community Support and Services Committee about the Path to Treaty Bill 2023.

The QFCC is a statutory body of the Queensland Government. Our purpose is to influence change that improves the safety and wellbeing of Queensland's children and their families. Our Strategic Plan 2022-2026 outlines our explicit commitment to Aboriginal and Torres Strait Islander children and their families and to embed culturally safe and responsive design, practices and delivery in our work. We recognise that self-determination, healing, dignity and respect are all fundamental elements needed to improve outcomes and relationships.

The QFCC is pleased to provide support for the Path to Treaty Bill 2023. We acknowledge the Bill as a significant and historic step for Queensland, one that builds on the hard work of generations of people working towards reconciliation and healing. We welcome its introduction to progress treaty negotiations and empower Aboriginal and Torres Strait Islander peoples to shape the future of their communities and Queensland as a whole.

The QFCC promotes accountability of the systems working with children, young people and families by overseeing and reporting on system performance. Through this work, the QFCC continues to observe the impacts of past policies and practices on present day drivers of overrepresentation of Aboriginal and Torres Strait Islander children and families in statutory systems, combined with their underrepresentation in decision making models that impact their lives.

The Truth-Telling and Healing Inquiry proposed by this Bill will be uniquely positioned to investigate both historic practices—and their legacy—as well as contemporary decision making, to understand their impact on Aboriginal and Torres Strait Islander peoples. Through our

oversight function, we are also committed to continuing to promote accountability for systems that disproportionately impact Aboriginal and Torres Strait Islander children and families and promote initiatives which could help guide solutions.

Further, we recognise that truth-telling is an important foundation to the treaty process and will have significant positive implications for the relationship and understanding between First Nations peoples and non-Indigenous Queenslanders for generations to come. As such, it is essential that this process is inclusive of all members of Aboriginal and Torres Strait Islander communities, including children, young people and families.

Engaging children, young people and families and listening to their views is critical for understanding their contemporary experiences of colonialism and discrimination, and identifying opportunities to improve systems they interact with. This will also help to empower children and young people to take an active role in shaping their future.

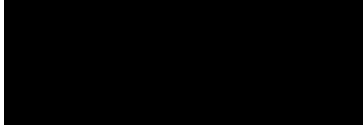
We encourage the truth-telling sessions to facilitate conversations with Aboriginal and Torres Strait Islander children, young people and their families in ways that are safe, accessible, and meaningful. Consideration should also be given to means for engaging with the most marginalised groups of First Nations peoples, including those experiencing statutory interventions, to provide opportunities to share their lived experience of current systems and injustices.

We acknowledge that Aboriginal and Torres Strait Islander peoples are strong, capable and resilient—the descendants of the oldest and continuous living culture in the world. They have made significant contributions to history and society, and it is important that their achievements and contributions are recognised and celebrated through truth-telling processes, as well as the Path to Treaty process. We look forward to a future where all Queenslanders foster a shared pride in First Nations cultures, where exceptional Aboriginal and Torres Strait Islander peoples who have made significant contributions to all aspects of our lives sit prominently in our historical frame of reference.

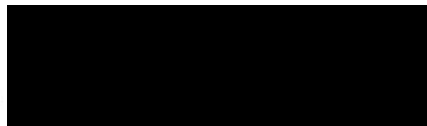

Dear Committee Secretary

The Queensland Family and Child Commission (QFCC) provided a submission, to the Community Support and Services Committee about the Path to Treaty Bill 2023 on 17 March 2023. The QFCC would like to include an addendum to that submission.

The QFCC has become aware of concerns regarding limitations to the powers of the Truth-Telling and Healing Inquiry that may exempt the Queensland Police Service from being compelled to provide information or to attend the inquiry. Under clause 85 of the Bill, only Government entities can be issued with an attendance notice to a truth telling hearing. The Bill defines Government entities by referencing section 276 of the *Public Sector Act 2022*. This does not include the Queensland Police Service.

The interactions between First Nations people and police in Queensland have had significant and enduring impacts, and the opportunity must be offered for truth telling and healing. These experiences are highlighted in QFCC's 2022 report [Yarning for Change: Listen to My Voice](#). The report spoke to over 100 First Nations young people about their experiences with youth justice, including policing.

The QFCC would recommend that the Bill be amended so that adequate powers be provided to the Truth-Telling and Healing Inquiry to compel the Queensland Police Service's involvement.

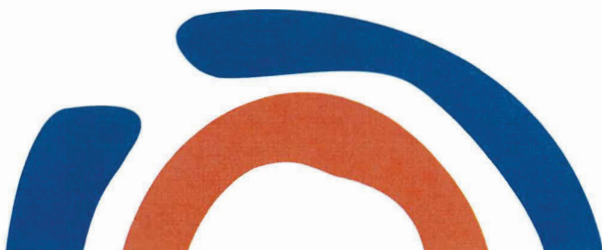
