## A Submission Pertaining to the Queensland Veterans' Council Bill 2021

I served as Vice Chair of the Queensland Advisory Committee for the Commemoration of the ANZAC Centenary (QACCAC) from 2013-2014 and as Chair from 2014-2019. During that time QACCAC provided advice on all aspects of Queensland's ANZAC Centenary commemorations and oversaw a number of Legacy Projects – one of which was the refurbishment and enhancement of Anzac Square (the State War Memorial) in Brisbane.

The following comments are made in the hope that they may assist the Committee's consideration of the Bill.

## **EXPLANATORY NOTES**

## **Estimated Cost for Government implementation**

The numbers in this section must be treated with considerable caution. Anzac Square has no Concept of Operations and no Strategic Plan – much less an Operational/Business Plan – from which an operating budget can be established. The basis from which the numbers were derived is unknown and they must, therefore, be considered 'a best guess'.

Apparently, the cost of the Office for Veterans will be found from the \$2.4m per annum which will leave very little over for the funding of the necessary Anzac Square staff and the ongoing curation, maintenance and oversight of the Square.

The second paragraph under this heading acknowledges that the costs of the maintenance of the Anzac Square parklands will be met by the State Government. Anzac Square is a considerable ornament to the city of Brisbane (and Queensland more broadly) and it is not unreasonable that Brisbane City Council (BCC) contributes to its operating cost. This could be as a contribution in-kind with the BCC undertaking to provide the on-going maintenance of the parklands — a similar arrangement exists in both Sydney and Melbourne. The existing wording in the Explanatory Notes, gives the BCC a legislated capacity to charge the State Government for such maintenance. According to the BCC's (albeit uncertain) internal

costings made available to the Anzac Square Steering Committee, the value of this in-kind support is some \$750,00 per annum.

Propose the amendment of the second paragraph of this section of the Explanatory Notes to read '.... These costs will be met by the State Government, in partnership with the Brisbane City Council, through ....'. This would at least provide an avenue to negotiate an in-kind contribution from BCC.

With the establishment of QVC, the costs of maintaining the Anzac Square parklands (in the absence of BCC in-kind support) will be found from the annual \$2.4m further reducing monies available for the curation, maintenance and oversight of the Square.

Clause 9 of the proposed Bill gives a broad outline of the functions of Anzac Square. It would appear highly likely that the monies remaining from the annual \$2.4m, once the costs of the Office for Veterans and the maintenance of the parklands are taken out, will only allow very limited curatorial, improvement and maintenance spending — to say nothing of spending on the broader functions of the Square as outlined in Clause 9.

## THE PROPOSED BILL

Comments on some of the Clauses in the proposed Bill follow:
