Dear the Community Support and Services Committee, cc my local MP -

I'd like to comment on both the Housing Legislation Amendment Bill 2021 and the Residential Tenancies and Rooming Accommodation (Tenants' Rights) and Other Legislation Amendment Bill 2021.

I'd also like to take this opportunity to share something with you: a snapshot of what it's like to rent in Queensland.

When I was renting in Coorparoo we had a unsafe house that had mould, leaking roof and stairs about to collapse, at one point during the tenancy my foot feel try the rotten floor boards, upon asking for maintenance I was informed there was nothing wrong with the premise by a unlicensed handy man, I then paid out of my pocket for a qualified builder to attend to write a report on urgent matters (floor and stairs)he found that the basement had a serious water leak making that side of the house unsafe. We lodge the report to the agent who then gave us a notice of intention to vacate on grounds of repairs, however the house never got repairs house rent wentf up \$60 dollars a week more and new tenants are currently living in a mouldy unsafe house. We didn't feel we could lodge a retaliation court documents as we needed the agent to provide a reference so we left got our bond back but there is still other renter now stuck in a slum Lord's home risking being homeless with no course of action to be taken as nothing can stop a agent giving a false reference.

In its current form, the Housing Legislation Amendment Bill 2021 will do little to improve my situation as one of the 1.8 million renters in Queensland. While this bill may be palatable to the real estate lobby, it completely disregards my experience as a renter.

While I'm pleased that the Housing Legislation Amendment Bill includes positive provisions for renters experiencing domestic and family violence, it contains little other reforms of substance for renters.

I urge the Queensland Government to take this opportunity to amend this bill and to implement real rental reforms that will make renting in Queensland affordable, secure and fair.

It's crucial that rental reforms in Queensland include:

- A genuine end to 'no grounds' evictions – providing tenants with long-term security in their homes without the risk of an unfair eviction at the end of their lease
- Allowing tenants to make minor modifications, like hanging picture frames or installing furniture safety anchors
- A real ban on rent bidding – banning agents and property owners from accepting amount above the advertised rent for a property
- Expanding minimum standards to include ventilation, cleanliness and insulation
- Stopping unreasonable rent increases by tying rent increases to general inflation (CPI)
- Ensuring prospective tenants have fair and honest information about the property

- Banning inappropriate or discriminatory questions by lessors
- Make it easier for tenants to have pets – by flipping the onus on property owners/agents to demonstrate why it's unreasonable for a tenant to have pet

These provisions are included in the Residential Tenancies and Rooming Accommodation (Tenants' Rights) and Other Legislation Amendment Bill 2021. I urge the government to either support the Tenants' Rights Bill, or amend its own bill to provide real protections for renters.
