Dear the Community Support and Services Committee, cc my local MP -

I'd like to comment on both the Housing Legislation Amendment Bill 2021 and the Residential Tenancies and Rooming Accommodation (Tenants' Rights) and Other Legislation Amendment Bill 2021.

I'd also like to take this opportunity to share something with you: a snapshot of what it's like to rent in Queensland.

I have been a Douglas Shire resident for over 8 years; at fourmile Beach renting through [REDACTED]; whom disregarded all my tenancy rights to the point that I could not live there any more therefore I left because I was concerned for my safety as there were incidences of violence, drunkenness and drug abuse. So I ended up homeless and resorted to stay with friends, eventually I ended at renting a room at [REDACTED]. There I was constantly abused by another resident and we had an altercation and she charged me with assault causing bodily harm which I am disputing. I was advised by police to leave those premises which I did to end up being overcharged for a room at the [REDACTED] which didn't go well because I had a run in with the drunks and drug addicts living there from there I was helped by the Mossman Community Centre to get accommodation at the [REDACTED]. That was a little better however I ended up moving to [REDACTED]

[REDACTED] where I have been for almost a year. As you can imagine it has been a horror 3 years

In its current form, the Housing Legislation Amendment Bill 2021 will do little to improve my situation as one of the 1.8 million renters in Queensland. While this bill may be palatable to the real estate lobby, it completely disregards my experience as a renter.

While I'm pleased that the Housing Legislation Amendment Bill includes positive provisions for renters experiencing domestic and family violence, it contains little other reforms of substance for renters.

I urge the Queensland Government to take this opportunity to amend this bill and to implement real rental reforms that will make renting in Queensland affordable, secure and fair.

It's crucial that rental reforms in Queensland include:

- A genuine end to 'no grounds' evictions – providing tenants with long-term security in their homes without the risk of an unfair eviction at the end of their lease
- Allowing tenants to make minor modifications, like hanging picture frames or installing furniture safety anchors
- A real ban on rent bidding – banning agents and property owners from accepting amount above the advertised rent for a property
- Expanding minimum standards to include ventilation, cleanliness and insulation
- Stopping unreasonable rent increases by tying rent increases to general inflation (CPI)
- Ensuring prospective tenants have fair and honest information about the property
- Banning inappropriate or discriminatory questions by lessors
- Make it easier for tenants to have pets – by flipping the onus on property owners/agents to demonstrate why it's unreasonable for a tenant to have pet

These provisions are included in the Residential Tenancies and Rooming Accommodation (Tenants' Rights) and Other Legislation Amendment Bill 2021. I urge the government to either support the Tenants' Rights Bill, or amend its own bill to provide real protections for renters.
