Special Education Schools were, at the time, full capacity and had lengthy waitlists, our school of choice for him, refused admission due to his high learning needs and so we found ourselves considering mainstream public education as our last resort. Placing our son in a Year 7 class with over 35 children, despite his academic and emotional level being closer to Year 2, was a daunting prospect. Our paramount concern has always been providing him with the best possible environment—one that is nurturing and tailored to his individual requirements.

I am writing to express my profound disappointment regarding the proposed changes to homeschooling legislation. For many families like ours, homeschooling isn't simply a choice—it's a lifeline.
