I know I would've greatly benifited from home, specialised learning. I have struggled with mental health since high school. Only now being diagnosed with ADHD, severe anxiety and asd at 28years old. The public system missed it, my parents weren't worried as they weren't told to, and I was left to cope on my own. The mental health rate of children IN PUBLIC Zander PRIVATE schooling is rising dramatically. Can we please touch on that, and how we can work proactively to solve it. Not only in home education, but in all schooling. 3.Safety and Well-Being: The legislation rightly emphasizes that home education must be provided in the best interests of the child or young person, considering their safety and wellbeing. As a homeschooler, I believe this principle is paramount. However, it is essential to strike a balance between ensuring safety and allowing families the autonomy to choose educational approaches that align with their values and circumstances.4.Red Tape and Streamlining: While streamlining laws is commendable, we must be cautious not to burden homeschooling families with unnecessary bureaucracy. The proposed changes should simplify processes without compromising our ability to provide quality education. Let us ensure that administrative requirements do not overshadow the joy of learning.5.Appeal Rights for Short-Term Suspensions: I appreciate the provision for appeal rights in cases of short-term suspensions. However, let us ensure that these rights are accessible and transparent. Students and parents should feel empowered to advocate for fair treatment and due process. In conclusion, I urge the Queensland Government to engage directly with homeschooling families, including young learners, before finalising any changes to the EGPA.
