To all the Members of the Economics and Governance Committee,

i, Stephen Legg of [REDACTED], have cause to respond to the proposed Bill above.

1. Why is such a period (April 2022) necessary when all data is pointing to the virus reducing effects and virility;
2. Why is such a Bill necessary when your Government already has extensive powers over the control of the mentally ill and impaired, as well as prisons and their inmates, also youth detention centres. It appears to be an over-reach at the least.
3. The Bill appears to be going beyond the limits placed by our leaders in 1900 when the Constitution was prepared and later accepted by The People.
4. Freedom of Travel and Association are Australian freedoms. The Bill takes away those freedoms. Inalienable Rights are just that. Thus, The Bill is unable to be enacted at Law.
5. The Bill refers to powers regarding mask wearing. There is overwhelming scientific evidence that proves the masks are totally in-effective in reducing the transmission of any virus. In addition, prolonged wearing of masks increases the risk to health for any person owing to increased Carbon Di-Oxide to levels that are toxic. All clauses relating to this are to be removed as it is contrary to the role of Government.
6. Dictates regarding the wearing of masks and medical procedures are also contrary to Common Law, the Constitution of Australia and is an extreme over-reach of Governmental powers. This includes any co-erced injection of any liquid or gas or solid.
7. Any Bill that encourages or empowers any person to inject any liquid gas or solid without Informed Consent is contrary to Federal laws. These over-ride State legislation.
8. The Emergency Powers are based upon a lie. There is NO pandemic based upon the accepted definition of the word Pandemic. (ie not the changed definition to weaken it)
9. As the lie that allowed Emergency Powers to be enabled was in deliberate ignorance of peer reviewed science then The Bill above is ir-relevant.
10. The role of all elected Politicians is to uphold the Rights of the Citizens of Australia. This comes before any Party or other interested parties beyond Parliament. A failure to carry out this highest role puts each Member in jeopardy and Lawful repercussions.
11. As a Citizen of Australia and Queensland, I demand that each Member of the Committee thus addressed, return The Bill to the floor of Parliament with a complete and utter rejection of content.
- 12 Further, each Member puts forward a reasoned speech to the effect that Parliament and advisers are to consult widely the peer reviewed science around the world regarding the Sars Covid -2 virus and the so called Vaccines along with the statistics of deaths and injury caused by the latter to date in Australia.

I am willing to provide links to such science and also to Reiner Fuellmich in Germany who has formed a committee to examine the German response to the so called pandemic. this committee has consulted widely amongst the most respected health scientists in the world and so far, the findings are that gross dereliction of duty occurred at the highest level of Government. That same dereliction appears to have occurred across every Parliament in Australia. It is time to end this and return our State and Country to as normal a state as possible - free of masks, lockdowns and restrictions.

14. The People are waking up and angry. Your committee has the power to at least start a reform of this corrupted and dangerous Government of Queensland.
