, through this submission, am responding to a Bill, currently before the Queensland Parliament.

A Bill for An Act to amend the Body Corporate and Community Management Act 1997, the Corrective Services Act 2006, the COVID-19 Emergency Response Act 2020, the Economic Development (COVID-19 Emergency Response) Regulation 2020, the Environmental Protection Act 1994, the Explosives Legislation (COVID-19 Emergency Response) Regulation 2020, the Gaming Machine Act 1991, the Health Legislation (COVID-19 Emergency Response) Regulation 2020, the Justice and Other Legislation (COVID-19 Emergency Response) Amendment Act 2020, the Mental Health Act 2016, the Public Health Act 2005, the Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Act 2021 and the Public Health and Other Legislation (Public Health Emergency) Amendment Act 2020 for particular purposes.

I have added to my records the sections of these Acts to be changed, and am responding to sections of this Bill dealing with the Covid response.

With respect, I write this submission to Queensland Parliamentarians, as an Allied Health Professional..a Queenslander and concerned citizen of Australia: and a Justice of the Peace dedicated to protecting the rights of our citizens as these rights are interpreted through the integrity of our laws and Australian Constitution.

In my view, this current bill being placed before the Queensland Parliament, is an overreaching of the current powers now enforced in this state (and nation), in response to the Covid 19 flu.

To extend these Emergency Powers to the 30th April, 2022, can only be interpreted as an attempt to deny citizens the right to move freely and gather within society, without being fined, traced or tracked via electronic devices or paper records; mask wearing, and subjection to unreliable testing procedures; and the never ending push and pull lockdowns and division of citizens, denying them their right to work, privacy and sovereign rights within our nation, and indeed the global nation of humanity.
