To who it may concern, concerning the NEW QUEENSLAND BILL EXTENSION OF  
EMERGENCY POWERS TO 30 APRIL 2022

My Name is Tina Thompson, I am a tax paying resident of Qld, My address [REDACTED]

Qld I strongly disagree with this amendment which is  
The Public Health and Other Legislation (Further Extension of Expiring Provisions)  
Amendment Bill 2021 extends a range of emergency measures, including the extraordinary  
powers of the Chief Health Officer, Dr Jeannette Young.

These powers include the ability to impose restrictions on the free movement of citizens,  
their ability to travel, conduct a business, attend school, church or sport, as well as the  
power to issue mandates on mask wearing, social distancing rules, the numbers of persons  
who can gather at any one time, border closures, area lockdowns and quarantine mandates.

I also believe that this was put through without the general public, who voted for this  
government to uphold our rights as citizens of Qld. We have lost our rights, rights that are  
law which is the basis of our country and state, and are being overruled by a government  
who were supposed to be working for the people. Families unable to see loved ones, the  
right to travel as needed or desired in our state and country, our every movement being  
tracked and controlled by the powers that be. Peaceful enjoyment of our lives put on hold,  
mental health affected and access to services restricted to electronic only methods,  
including health care, mental health care, contactless payment, reduction in the ability to  
use cash which is a fundamental right, the mandatory vaccine for aged care workers  
against their will, even when residents can refuse the vaccine, people of all ages with no  
contact with loved ones and friends because of the govt states it has to be this way. Even if  
that's a Federal decision you have agreed to this. Suicides increasing substantially because  
people are left with very little hope. Homeless and people with mental health issues unable  
to access face to face help because of covid. It saddens me that our lives have been put into  
a state of constant alert, my elderly parents are afraid to go out and enjoy their remaining  
days, my teenage daughter filled with anxiety about going to the Sunshine Coast when we  
were originally from to visit relatives and friends and could not see people, anxiety  
affected her as she tried to use masks and could not cope with the feeling of suffocation  
and worry of crowds when trying to buy clothes because we live in a remote area and can't  
buy things needed in our home town. Checking in constantly to places and watching news  
broadcasts where there is constant talk about how important it is to have a vaccine that  
causes blood clots in a small number of the population, How do we know that we aren't  
going to be that small number. These vaccines were rushed through and there is no way  
that we can know all of the information needed to make an informed decision. It takes  
years to know some of these facts, I have young adults as children and there is no way I  
want them putting themselves in the situation where they might be the small number of  
people affected by blood clots. Pfizer having it's other There isn't enough information  
about affects on fertility as so have daughters who are child bearing age who are yet to  
have children. My parents who are frail apparently have less chance if being affected or is it  
just that they are elderly and not valued enough and if something happens it's only a small  
percentage of the overall number. We are not statistics. We are people who have lost our  
rights to choose. Vaccinated people will soon not have to quarantine ECT. They can still  
get the virus and pass it on, even if it's less chance, it can still happen, we were promised  
that we wouldn't be forced, so it's have it or lose your job. Have it or you can't move

about. I refused to agree to this Bill and it's controlling powers over our population.
