Dear Committee Members,

I do not consent to the extension of emergency powers to 30 April 2022 as proposed by the Public Health and Other Legislation (Further Extension of Expiring Provisions) Amendment Bill 2021.

There are crimes against humanity being perpetrated at alarming speeds across the world in the name of 'keeping people safe from Covid', a virus that has an extremely low mortality rate (99.7% of people recover & it mostly affects the elderly & infirm, just as the flu has time immemorial),

Queensland is fast implementing fascism similar to Nazi Germany, it's is wielding unprecedented power to control & to dictate to the people. Declaring a state of emergency & extending it over & over again (ad Infinitum) to hold onto that power will only entrench these kind of fascistic tendencies further meaning at the rate we're going, democracy as we know it will soon be a thing of the past.

Since when is it considered humane to deliberately keep mothers from new babies & keep families from their elders in retirement homes at the end of their life? Why is compassion being deleted?

Since when do we shut down our economy for a virus that over 99% of people recover from & the media is allowed to continue its fear mongering campaign? The mainstream media is the virus.

Since when has it been ok to encourage people to take experimental medical treatments in order to continue work, play, interact with others & the system? Emergency use authorisation is a mass population scientific experiment & it is not ok that people are not being advised of the risks by governments who are promoting this solution to end lock downs.

Since when has the evidence of harm in the bigger picture not been taken into account in making nuanced policy decisions? E.g. suicide rates, business closure, homelessness etc.
