Dear Sir or Ma'am as Directive,

Greetings,

My name is Latez Jones a local member of a Brisbane City community here in Queensland, Australia. For recognition I would like to acknowledge the traditional landowners of this continent being forever as Aboriginal and Torres Strait Islander.

My main intent is to the Veto the bill known as Directive: Extend the State of Emergence in Queensland. Which as outlined will give central powers such as premiere and cabinet to impose restrictions on the citizens and peoples of this state. To be light in travel freely, be subject to contact tracing, quarantine and self isolate. Extend powers to Health minister in any directive to evoke Marshall law.

Where we are to be boarded in our homes with no contact with anyone less than 10 if outside of family members. And social gatherings are limited to 20 people or less. However I would like to point out that since the pandemic.

That only 7 confirmed COVID-19 deaths from the disease has been confirmed and Australia as a nation only has 10, 000,000 people. Contact with the disease has been known to have come from people travelling into the country not leaving out.

That would be in regard to tourists and students on visas as well as backpackers while during this time the suicide rate has become rampant, and the actual mask covering has been proven to not withstand anything from the disease.

As well I must remit that only 7 COVID-19 related deaths and 3 deaths from the injection of the AstraZeneca vaccine. Has not shown to stop the disease also other medical experts from the Daniel Andrews Administration has also confirmed wearing the mask has more bacteria and does not protect against the virus.

Social distancing and encouraging a cleanly area are pre-emptive measures to stop it but extending the parameters of lockdown will lead to an anarchist estate of the rich imposing bandits upon the social economy and more disadvantaged.
