Re: Public Health and Other Legislation (Further Extension of Expiring Provisions) Amendment Bill 2021

5 July 2021

To whom it may concern,

With reference to the Amendment Bill 2021, I would like to lodge a submission against it, in light of substantial evidence that confirms the inappropriateness of the suggested extension of the operation of a range of legislative measures.

The evidence is as follows:

- 1. The "pandemic" has been declared based on flawed testing as the PCR test was never designed to "diagnose" any illness, as it cannot detect a live infection.
- 2. A positive PCR test does not mean that an individual is infected nor infective.
- **3.** Viral fragments may remain in people's bodies for several weeks following recovery from infection.
- **4.** The crisis will never end if we are waiting for zero positive tests. Everyone has probably had a cold caused by a coronavirus and will likely have a few viral fragments matching those of the cousin SARS-CoV-2 virus.
- **5.** Testing healthy asymptomatic individuals is non-sensical, unscientific and a colossal waste of money.
- 6. The Government wants us to continue to wear masks even though they have no scientific evidence that they work to stop you either getting the disease or transmitting it.

- 7. We have never locked down society for a respiratory virus before.
- **8.** There is **no scientific evidence** that lockdowns work.
- **9.** The basis for lockdown was a mathematical model by Professor Neil Ferguson. Professor Ferguson's modelling was not even peer reviewed before being acted upon by several nations.
- **10.** Professor Ferguson has a long track record of woeful modelling he was entirely wrong about sars, mers, mad cow's disease (CJD), and swine flu. Why did the world listen to him again?
- **11.** Countries which did not lock down Sweden, Japan, Taiwan, South Korea and Belarus have all done significantly better than us in terms of percentage of population deaths. They also have herd immunity and intact economies.
- **12.** There is **no scientific evidence** that social distancing works.
- **13.** Placing the public under virtual house arrest has caused untold damage to both physical and mental health.
- **14.** Reports from other countries confirm the majority of people who have died since the appearance of Covid-19 had significant comorbidities, such as Alzheimer's, cancer, cardiovascular disease and diabetes.
- **15.** It is common knowledge that counting death certificates with a 'mention' of Covid as being a death caused by Covid is a gross misrepresentation of the facts and has vastly over exaggerated the death toll.
- 16. The medical profession in several countries have not been allowed to let the public know that Covid wards have been empty for months, nor that Covid deaths have reached an all-time low for months, and this has unnecessarily added to the public's distress and anxiety.
- 17. For a disease that has an infection fatality rate of <0.1% for most of the population (aged <70 years), the usefulness of mass vaccination programs is currently questionable, especially in the absence of robust safety data. Even in the elderly, aged >70 years, the recovery rate from Covid-19 is in the range of the claimed effectiveness of the currently approved vaccines.
- **18.** In the beginning of June 2021 Professor John Skerritt of the TGA admitted in Parliament that these injections are experimental.
- **19.** Greg Hunt confirmed we are in the biggest clinical trial of all time.
- **20.** Australian people were not properly advised of this nor the risks, including serious injury and death. There is nothing wrong with somebody choosing to participate in an

experiment, but they need to give proper **informed** consent to doing so. By "informed" I mean understanding the ingredients of these vaccines, the fact that Phase 3 trials have only been running for 6 months, and that the short and long-term possible effects of these injections are still unknown.

- **21.** Invalid Commonwealth Consent forms were obtained from people, who did not know they were signing up to be in an experiment, and that people could be injured or die from this experimental product.
- **22.** The Government has lied and mislead the Australian people into believing this is a vaccine when it is an experiment. People are dying (over 300 so far in Australia of those reported) and are having serious adverse reactions.
- **23.** The injection has not been properly safety tested. Not enough testing has been done on people with comorbidities, pregnant women or the elderly and yet it being injected into them with disastrous consequences.
- 24. Published claims of effectiveness were based on interim analyses of trial data, assessing an extremely small number of trial participants. This numbered only 94 out of 40,000 participants in the Pfizer trial (0.2% of the total cohort) who were the first participants to develop mild symptoms and who tested PCR positive for SARS-CoV-2. The efficacy claim is based on the fact that 95% of this small group was in the placebo arm. Due to the small numbers, we consider that this has limited statistical significance and, in any case, is only a measure of Relative Risk Reduction. Closer scrutiny of the figures reveals that the Absolute Risk Reduction to an individual inferred by the vaccine is only about 0.4%. In addition, the full raw trial data is yet to be published and multiple cases of clinical disease, including two cases of serious disease in the vaccine group, were not included in the analysis, as they were not confirmed with a positive test.

There are effective and safe treatments and preventative medications for Covid such as Hydroxychloroquine and Ivermectin, or vitamins D, C and zinc, therefore there is no need for any lockdown restrictions and associated measures. The pandemic is essentially over as can be seen by the consistent low death rate and hospital admissions over the past four months. Lockdowns do not save lives, which is why they have never been used before. Civil liberties and fundamental freedoms have been unnecessarily removed from the public.
