Here is a story from a friend- Belinda, "I was threatened with being removed from QLD childrens hospital last week as i have a gp and cardiologist exemption letters for mask wearing. But it is mandatory in hospitals with no exceptions. They gave me a face shield which i still passed out wearing. So they forced me to wear it with a nurse escorting me to bathroom, or to doors of hospital, the nurse carried oxygen and resus kit for when i passed out in the corridors.

It was so disgusting and humiliating. I am dreading the next few weeks of appointment for the girls"

Again, how can you justify that this is okay that this is happening in our state? Absolutely disgusting and illegal! I miscarried in August 2020, I hemorrhaged, yet due to restrictions on top of what I was already emotionally and mentally suffering with through this process I couldn't cope with the idea of having to go to the hospital, being required to wear a mask and not knowing if my husband could be with me. This resulted in me opting to stay home, yet being neglected of medical care that I should have received. Also, most gp clinics are not allowing you to see them if you have any cough etc symptoms, so you then have to go to emergency and sit there for 6hrs for something simple. This is just creating the overrun hospital problem that is then being plastered on the media, when a gp is totally capable to deal with these issues but are obviously afraid or being threatened or pressured. Colds are still around! Why are we feeling like lepers for having a cold? I cannot include the thousands of other stories that I have come across. The media isn't sharing that are they? Which is obviously then biased and twisted.

In regards to masks, my husband didn't feel the need to wear one during the April lockdown, he worked in a factory room, on his own in a chlorinated and mouldy room, his work stated it was required and work policy to wear the masks. They asked for evidence of an exemption, which goes against the privacy act. After stating that they cannot legally force him, they eventually agreed, yet placed him outside washing bins. For 6 weeks! This is in violation of the privacy and discrimination acts. We can sue. Others have sued for similar situations.

Restricting churches and church meeting violates our constitution section 116 "

116. Commonwealth not to legislate in respect of religion

The Commonwealth shall not make any law for establishing any religion, or for imposing any religious observance, or for prohibiting the free exercise of any religion, and no religious test shall be required as a qualification for any office or public trust under the Commonwealth.

In regards to the covid vaccine, it is on the TGA website that over 300 people have died and thousands have reacted. If you look up "the highwire" on bitchute, Del Bigtree was a producer for Dr Phil and "the doctors" programs, he has interviewed scientists who worked on the vaccine, they are regretting making it and warning against it's side effects and it's experimental status. Firstly, that violates the constitution, secondly, it violates our democratic freedom of choice, thirdly it is discrimination. **Section 3:**20 Goods, services and facilities It is unlawful for a person (the provider) who (whether for payment or not) provides goods or services, or makes facilities available, to discriminate against another person—(a)by refusing to provide those goods or services or make those facilities available to the other person; or(b)in the terms or conditions on which the provider provides those goods or services or makes those facilities available to the other person; or(c)in the way in which the provider provides those goods or services or

makes those facilities available to the other person.

Yet the government is putting pressure on businesses, when all they are required to do is display the check in sign, they should not be enforcing it and going against our choice and right to privacy.

I also know of many who have family in other countries yet they have not been able to see them, this is totally wrong and should not be happening either.

I plead with you to stop enforcing illegal lockdowns, mask mandates and restrictions. Stop violating our constitutional rights and freedoms to choose. Stop giving out incentives and manipulating people to receive a vaccine. Stop making businesses choose to enforce the vaccine to keep their job. This issue is being fought in the high court also. It does not take a genius to see the problems you have caused to people, families and our economy. This was all totally avoidable. There is a lot you will have to answer for, for the sake of the Australian public who have lost so much more and are suffering at your hands.
