**Re: Public Health and Other Legislation (Further Extension of Expiring Provisions) Amendment Bill 2021**

Dear Sir or Madam;

I would like to strongly oppose the extension of all points in the expiring provisions in the Public and Other Legislation Amendment Bill 2021 tabled to the Committee by the Minister for Health and Ambulance Services, the Hon Yvette D'Ath MP.

My reasons are as follows;

- Subsequent to the beginning of the disastrous response to the “pandemic” there is now irrefutable evidence that there is no “pandemic” and it is now proven that governments around the world in their attempt to justify a complete overreaction, falsely inflated COVID-19 numbers and attributed many other comorbidities to COVID-19 and recorded them as such.
- The data now shows that all scientific modeling that led to the initial worldwide response was grossly exaggerated and subsequent responses have been just as bad, and in some cases, worse and it has all been based on flawed science.
- Following a citizen’s petition recently, a Lisbon Court in Portugal was forced to provide verified COVID-19 mortality data and in doing so it was revealed that 152 people had succumbed to COVID-19 and not the 17,000 that was claimed, 0.9% of verified cases. The affects that the current responses to COVID-19 have been disastrous, not only have ten's of thousands of people lost their livelihoods, there has been an unprecedented increase in all other health related issues, one has to only see the data and/or speak to healthcare professionals, particularly those in mental health to realize the extent of the problem.
