**Re - Public Health and Other Legislation (Further Extension of Expiring Provisions)  
Amendment Bill 2021**

Dear Member/s

This letter is regarding the Public Health and Other Legislation Amendment Bill 2021 and related public submissions due on 7<sup>th</sup> July 2021 at 5pm.

After reading the proposals presented in the bill amendment, we, as new Queensland residents, feel great concern about the direction this state and other states are taking. We *escaped* Melbourne in March 2020, and made Brisbane our new home. In the process we have seen the devastation in Victoria following the prolonged lockdowns.

So far, the events of 2020 have delivered the following effects (but not limited to):

- ✓ Suicides that have been covered up and never discussed publicly (adults and children)
- ✓ Bankrupted businesses
- ✓ Immeasurable economic loss to already struggling population and charities
- ✓ Immeasurable mental health issues to non-functioning **and** functioning people within the community, including disruption to education and training
- ✓ Damaged the national economy beyond repair with creeping national debt
- ✓ Removal of peoples' rights to see their dying and sick family members
- ✓ Created social disorder and division that we are yet to see the outcome of, which we will in coming months and years

- ✓ A nation **divided** where families, and functioning social members of society are forced to flee their state of residence to avoid punishing rules and regulations that destroy individual sovereignty and autonomy
- ✓ Since March 2020, there has been total disregard to other local and international professional medical personnel who voiced valid responses to what is being presented by current authorities
- ✓ There has been a systemic censorship of information by the media, and no allowance for deliberation or discussion
- ✓ Forced medical procedures that are questionable at best, and disregard of existing scientific research
- ✓ Exit of medical staff from the health system that will be detrimental to Queensland (and Australia), and lack of essential treatments and diagnosis
- ✓ Exponential increase in domestic violence and child abuse **reports**
- ✓ Disregard to full disclosure occurring through Senate hearings in Australia and overseas

The WHY for this submission

Some of our family arrived in Australia after WW2, as a place for hope and freedom. My immediate family arrived in April 1986 after leaving Lithuania in 1973 and later Israel in 1986. Although life was not always easy, we managed to overcome many hurdles and be very proud of our achievements. Australia is our home, and for that we as citizens must protect her.

The proposed amendments are concerning as they, while purporting to protect the population, encroach on human rights, rights to move freely, breath freely, and autonomy. The role of an **unelected health official** determining the plight of citizens would hardly qualify as democratic. The infringement of many international human right laws is also alarming.

While the following are personal views as to why the amendments **MUST NOT BE APPROVED**, they are based on publicly available information. The approaches and public notices issued since **March 2020** have clearly shown that first, the degree of **GLOBAL inconsistencies** is highly indicative of intentional disruption to human life as we know it. Literature from EVENT 201, false modelling by the Hopkins Institute, and recent revelations on Fauci's history and emails, are proof. Second, the implementation of individual states to

coerce medical procedures, use testing procedures that do not comply with the inventor's protocol, promotion of fear and anxiety, use of celebrities and photo opportunities to promote an experimental drug that has not passed safety tests, and breach of The Australian Constitution 1901 are further proof of intentional disruption. The silencing and penalisation of medical personnel to use less intrinsic methods is also noted. Third, and final point, while the world is slowly moving to normality by opening borders, Australia still maintains closed borders while permitting celebrity and other high-profile people to enter while thousands of Australians are still unable to return.

Many awake people know and see what is unfolding. After what started as '2 weeks to flatten the curve', has become an exercise in erosion of many rights and Australian way of life that our forefathers fought so hard to protect. Our FREEDOM is a non-negotiable even if it is sold as a pandemic. As was recently stated by key military personnel, **no one died from Covid19 in Australia**. As I am limited with time for this submission, and therefore unable to supply evidence to support my claims, we know that we are NOT alone in feeling and knowing the undercurrents. The delusional and corrupt narrative of the mainstream media falls on deaf ears because we do not participate in that dialogue. We observe from afar and hope that this race to self-destruct will stop. There will be no winners, except many angry losers. That is NOT the Australia that we know.

Therefore, we urge you to re-consider the proposal to implement these tyrannical ideas, and supply greater transparency as to **who makes the decisions and who stands to gain**. The support for these changes will forever change the landscape of Australia, and while we chose not to have children, the effects will be remembered in history as epic failure because the cracks are already showing.

Finally, we hope and trust that you will see the wisdom in our submission to **STOP** the enactment of these amendments, so that Australia can start healing from this trauma.
