- amendments relating to bodies corporate and the manufactured homes sector (including providing for the deferral of fee contributions and limitations on increases to site rent) - NO WAY
- various measures to facilitate the holding of state by-elections and local government by-elections and fresh elections in a COVID-safe manner NO WAY
- provisions enabling variations to liquor licensing to support temporary takeaway sales by operators of licensed venues disrupted by COVID-19
 - NO WAY
- public health related provisions governing the care of persons with a cognitive or intellectual disability, the delivery of mental health services, the operation of prisons and youth detention centres, and related measures. NO WAY

ENOUGH IS ENOUGH. The people of Australia have been through enough. The idea of having Qld in a constant state of emergency for another 7 months is abhorrent. The rise of anxiety, mental health issues, alcoholism, domestic violence is through the roof. You may not care about the people of this state, but we do. It's time to take us seriously.

We have a right to go to church and worship. We have a right to live peacefully without fear of our government overthrowing our holiday plans, we have a right to open businesses and keep them open, we are all essential workers, and we have a right to feeling peaceful in our nation without fear of forced vaccines that have not yet been trialled properly.
