To whom it may concern

I am making this submission regarding QLD's Public Health and Other Legislation (further extension of expiring provisions) amendment bill 2021, in which you are seeking to not only extend the current measures for longer durations, but also to increasing the amount of measures (and therefore fines) that the government can impose. This submission has been sent prior to 7th July 5pm as required.

I am very strongly opposed to an extension to these already tyrannical, unnecessary powers and breaches to human rights. I was not informed nor voted for a dictatorship or to live in the state of Queensland instead of Australia. In fact I have never been formally informed of any of the ridiculous rules that have come with this legislation, instead the Qld Government sees it fit to notify people of any new rules they have decided to make up through social media and mainstream media, neither of which I pay any attention to. In a free society I should be able to make my own obviously far more educated than QLD health decisions for my health

These Powers CANNOT be extended because the QLD Government, QLD Health and QLD Police service have proven consistently that they cannot be trusted with such power. The Police are out of control assaulting people for not wearing a face mask. A ridiculous new rule in Queensland with absolutely NO Scientific evidence south power. In Police are out of control assauting people in lot wearing a race mask. A fluctuous leve flue in Queensiant with absolutely NO Scientific evidence to support it. A total of 7 deaths from Covid in QLD, and 910 in the whole of Australia since the start of Covid in January 2020. Also in 2017 Diabetes took 4,839, Dementia took 13,729 and the highest killer was heart disease at 18,590. Whilst also causing an increase in suicide and death by domestic abuse, "In Queensland, since 1 May 2018 until 1 May 2019, eleven people have died as a result of domestic violence". Then their are the family violence suicides One hundred and twenty people involved in Queensland domestic and family violence cases died by suicide in the three years to last July.
