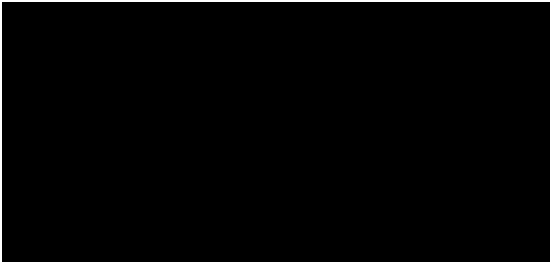

Re - New Bill to extend Public Emergency Response measures from 30 September 2021 till 30 April 2022.

My name is Tarnia Evans, Law Student of Southern Cross University.

The following is my submission against -The Public Health and other Legislation (Further Extension of Expiring Provisions) Amendment Bill 2021.

I will be publishing and sharing this my submission on Social media, as the public has the right to know what is really happening in this country, and how the truth is being misrepresented and manipulated by the Australian Government in its response to Covid -19.

THE ARTIFICIAL CRISIS CREATED BY FEAR NOT EVIDENCE

All Australian's are under our government's response to Covid 19, bearing witness to the Gravest Injustice our society has ever experienced. The degree of this governments over-reach has resulted in the most profound fear/hysteria and completely unwarranted loss of personal freedoms enforced upon Australian citizens in our nations entire history.

Governments response to the pandemic globally:

'It was a massacre, a public health blunder of the top magnitude probably the worst in the last century.' Professor John P.A. Ioannidis, Stanford University,

the world's most cited physician, scientist and researcher of evidence-based medicine, epidemiology, clinical research including meta-research in Social Sciences.

LOCKDOWNS

1. Lockdowns originated on the Order and Policy of Xi Jinping, General Secretary of the Chinese Communist Party, and were propagated into Global Policy by the World Health Organization in 2020.¹ Despite the fact that the WHO's own 2019 guidance for pandemic influenza did not advise border closures, mass contact tracing, or quarantine even of 'exposed individuals' under any circumstances.²

2. In the words of Judge William S Strickman, ruling in *Butler v Wolf* :

*It appears as though the imposition of 'lockdowns' in Wuhan and other areas of China – a nation unconstrained by concern for civil liberties and constitutional norms- started a domino effect where one country, and state after another imposed draconian and hitherto untried measures on their citizens.*³

3. The idea of locking down an entire State or Country for lengthy (weeks, months) and indefinite periods of time and forcibly shutting down its businesses, public places, preventing children from attending schools, was never entertained, never discussed and never implemented in any pandemic literature, guideline protocols or by any scientific peer reviewed academic paper prior to 2020.
4. Anytime anyone endorses or forces a 'Lockdown' on any free Democratic society for any length of time, even a few days, are endorsing a Communist Xi Jinping Policy.
5. It is now eighteen (18) months since the alleged Covid 19 pandemic began, and despite many emerging authoritative peer reviewed evidence based papers being available that SIP (shelter in place) / Lockdowns do not prevent the spread – the Lockdown Equilibrium continues across this State of Queensland and Nation.
Traumatising all Australians unnecessarily.
6. The Effects of Lockdowns.

Lockdowns (SIP) may reduce Covid-19 transmission, however their impact on overall health is unclear and is evidently being dismissed by the Health Experts leading the Covid-19 response in this country. Lockdown policies have several important unintended consequences (Correia, Luck, and Verner 2020). Lockdowns might lead to unemployment or reduced economic activity (S. Chen et al. 2020). SIP policies may increase stress and anxiety due to social isolation (Xie et al. 2020; Patrick et al. 2020), potentially leading to increased substance use and suicides (Mason et al. 2021; Holland et al. 2021).

Professor John Ioannidis (Stanford University) :

'We have multiple surveys from around the world that suggest we have doubling and tripling of the rate of mental health problems during the pandemic. Same thing for

anxiety, same for depression, some countries did worse some did better. Overall we have a major, major problem. Most people faced mental health problems during the pandemic.

We have solid evidence that 0.1% of the population died with or from Covid, probably mostly with, and fifty (50) percent of the population just got nuts.”

Reduced physical mobility may have also caused increases in child abuse and domestic violence (Leslie and Wilson 2020; Cappa and Jijon 2021), which can adversely affect health in both the short and long run (Sonu, Post, and Feinglass 2019). Recent work also suggests that SIP policies reduced use of high value non-COVID care such as cancer screenings and vaccinations (Cantor et al. 2020; Whaley et al. 2020; McBain et al. 2021). These complex effects suggest that SIP policies might reduce COVID-19 related mortality, but might also increase mortality from other causes.

7. The impact of Lockdowns (SIP) on - All Cause Mortality.

In an academic article titled: ‘The Impact of Covid-19 Pandemic and Policy measures on Excess Mortality.’ The authors conclusions are as follows:-

We fail to find that SIP policies saved lives. To the contrary, we find a positive association between SIP policies and excess deaths. We find that following the implementation of SIP policies, excess mortality increases. The increase in excess mortality is statistically significant in the immediate weeks following SIP implementation for the international comparison only. ⁴

1. The material risk of being infected with the coronavirus.
2. The material risk if infected of being hospitalised by the coronavirus.
3. The material risk if infected of not being hospitalised by the coronavirus.
4. The material risk of dying from the coronavirus infection.
5. The material chance of recovering from the coronavirus infection.
6. The material chance of having an asymptomatic infection.
7. The numbers of people with existing antibody immunity or memorised T cell response.

Our Government and Health Officers in failing to proportionately and honestly inform all Australians of the real threat of Covi-19 have therefore breached- The Nolan Principles of Standards in Public Life.
