To the Committee Secretary,

I oppose the extension of the Public Health and Other Legislation (Further Extension of Expiring Provisions) Amendment Bill 2021.

For the reasons of:

In Regards to the amendment of ‘increased powers for emergency officers and the Chief Health Officer to impose restrictions on the movement and interactions of persons, facilitate contact tracing, and enforce quarantine requirements’:

- To date there have been 7 deaths related to the “virus”, within the population of Queensland, (<https://covidlive.com.au/report/daily-deaths/qld>), as the estimated number is at 5.18 million, it would suggest that the deaths are such a small percentage how can we justify the need for legislation that can enforce such extreme measures; that allow for mandates, such as the removal of our constitutional rights to work, gather with loved ones and move freely within our country? Also, given the CDC in America has recently admitted that there is no gold standard for the isolation for any virus anywhere in the world, including SARS COV2, how can any of the measures including lock downs, masks, social distancing and the experimental vaccine be justified? - Lock downs are also a breach of our freedom of movement, according to Section 19 of the *Human Rights Act 2019* says that: Every person lawfully within Queensland has the right to move freely within Queensland and to enter and leave it, and has the freedom to choose where to live, (<https://www.qhrc.qld.gov.au/your-rights/human-rights-law/freedom-of-movement>).
- Mandates being treated as law; no mandates have passed as legislation and as such are not law, given this, the High Court will likely find all arrests of protestors and challenged fines to be unlawful, ([https://www.swinburne.edu.au/news/2020/09/high-court-likely-to-free-covids-political-prisoners/?fbclid=IwAR2L-fB15KNcF7GWoIyje8zV0fvRQfdh7OgFXCLos\\_16Y0MazdL0DWvR\\_ic](https://www.swinburne.edu.au/news/2020/09/high-court-likely-to-free-covids-political-prisoners/?fbclid=IwAR2L-fB15KNcF7GWoIyje8zV0fvRQfdh7OgFXCLos_16Y0MazdL0DWvR_ic)), while this article refers to Victoria, the same principals apply for QLD). The changing of legislation without giving the public an ability to be involved in the decision-making process is not democratic.
- The data collection with the check-in mandates are in short, similar to that of Communist China or Nazi Germany, restricting the freedom of the peoples’ ability to undertake their constitutional rights.

In regards to the proposed amendment of ‘public health related provisions governing the care of persons with a cognitive or intellectual disability, the delivery of mental health services, the operation of prisons and youth detention centres, and related measures’:

- To mandate an experimental vaccine, to work in certain environments or for travel freedoms is a breach of The Australian Constitutional Guarantee, section 51.23A, and as such is unlawful and illegal, the constitution itself states that these mandates are not within state parliamentary jurisdiction and therefore an illegal use of power.

In addition:

- The wearing of masks; so far, most studies found little to no evidence for the effectiveness of face masks in the general population, neither as personal protective equipment nor as a source control, therefore should not be ‘mandated’ as a requirement for movement in the community, (<https://swprs.org/face-masks-evidence/>). In fact there is much evidence to suggest that the use of cloth masks by individuals may actually put them at increased risk of respiratory illness and viral infections and their global use should be discouraged, (<https://newsroom.unsw.edu.au/news/health/cloth-masks-%E2%80%93-dangerous-your-health>), not to mention corona virus waste has become a new form of pollution as single-use personal protective equipment (PPE) floods our worlds oceans, (<https://www.weforum.org/agenda/2020/06/ppe-masks-gloves-coronavirus-ocean-pollution/>).
