Subject: I oppose the proposed QLD Bills to extend emergency powers to 30 APRIL 2022

I am writing in response to the proposed "Public Health and Other Legislation (Further Extension of Expiring Provisions) Amendment Act 2021."

Over a year into this situation with COVID-19, we are still experiencing border closures, harsh lockdowns, severe restrictions on the freedom of the people of Australia, and severe restrictions on commerce.

The Queensland government continues to encourage (at best) experimental injections by (currently) Pfizer and AstraZeneca, whilst completely ignoring (and actually making it extremely difficult to acquire) the possible treatment and prevention available from Ivermectin, vitamin D, and other vitamin and mineral supplements that have been shown effective (via peer reviewed studies) in the treatment and prevention of COVID-19 in other countries. This is not only a misuse of public funds, it also places the people of Queensland, and Australia as a whole, at serious health and financial risk due to the COMPLETELY UNKNOWN long-term effects of these experimental injections. I personally know of several people who have had SEVERE reactions to these injections and have seen many, many reports from official overseas adverse reaction reporting platforms such as VAERS. The TGA's own adverse reaction reporting system is displaying SIGNIFICANT numbers of serious adverse reactions. I cannot fathom how a supposedly responsible and care-taking government could possibly be pushing for these use of these novel, mRNA-based, genetically modifying injections as the sole mechanism for addressing COVID-19, when their long term effects are, again, COMPLETELY UNKNOWN.

The response to COVID-19 has been at best severely overreaching, considering the very high recovery rate for patients with COVID-19. Continued lockdowns, border closures, and limitations of freedom of movement and freedom of commerce have had devastating effects on people's mental and physical health, relationships and livelihoods. This is a huge violation of the public trust especially considering that these measures are not supported by the laws of Australia and our Constitution.

The Queensland Government (and Australian Government as a whole) has proven they cannot be trusted to act in the best interest of the population at large. This Act that the Queensland Government is seeking to extend provides unelected staff the continued ability to impose an emergency response to a situation that is no longer (and in my and many other highly educated medical and scientific professionals' opinions, has never been) an emergency. Zero tolerance of COVID-19 is an unachievable, frankly ridiculous, completely unnecessary and seriously damaging approach to the management of a virus, especially one with the very high recovery rate seen with COVID-19. Most other countries are returning to a relative state of normalcy, recognising that viruses must be lived with, not stamped out at the expense of almost every facet of life for their citizens.

I am completely in opposition to the extension of the Act, in particular the measures that do ANY of the following:

- * Limit the free movement and association of people
- * Limit the freedom of commerce
- * Attempt to impose mask wearing on any citizen. The Australian Government's own advice back in March 2020 was that mask wearing was not necessary or effective for healthy individuals.
- * Impose ANY restrictions on those citizens who CHOOSE not participate in the experimental injection trial for COVID-19 currently ongoing in Australia
- * Impose on or coerce any citizen via any means to be injected with the experimental injections for COVID-19 currently on trial in Australia, including for the purposes of work. This is against our Constitution.
