

Subject: New SOE Legislation Ammendments

Dear Member of Queensland Parliament,

I am writing to you to express my deep concerns about the future of Queensland.

The Public Health and Other Legislation (Further Extension of Expiring Provisions) Amendment Bill, which was tabled on 16 June 2021, has come to my attention.

I wish to express my strong opposition to the adoption of this bill. I also want to know why no communitiy consultation or notification has been made.

This bill represents huge over reaction and over reach to covid 19, and adds to the fast erosion of our inalienable rights.

Covid19 is now a very treatable illness for most, and it is very clear which cohorts are at greater risk. Early treatment is very safe and avoids hospitalisation, severe illness, death and even long covid in up to 85 % of infections. These treatments also act as very effective preventions. C19 has been shown to be very treatable if protocols are started early - even in the elderly and other at risk groups. Treatments are, and will continue to be important... Vaccination is not and cannot be the only answer, particularly as the fully vaccinated will still develop c19. This is being seen overseas in considerable numbers.

Many, many Queenslanders know these facts, and are growing increasingly frustrated that is not part of the discussion.

Many in the community appear to have preexisting immunity through exposure to previous corona viruses. Not everyone who comes in contact with sarscov2 will become ill. Most who do become ill, only have a mild illness. Any one becoming ill or needing hospitalisation could actually be avoided with the implementation of EARLY outpatient treatment.

Community Lockdowns and restrictions have been shown to have made little impact on the occurrence and evolution of outbreaks. This is in line with pre-covid thinking and policy on epidemics, especially viral respiratory ones.

Community Lockdowns and restrictions INCLUDING BORDER closures/restrictions are destroying small businesses; unnecessarily disrupting education; causing untold emotional distress, esp to those of all ages in care and those who love them; diminishing the richness of the lives of the disabled and elderly, and the community in general; destroying the vibrancy of our arts and music and tourism industries; separating families who live in different states; causing avoidable strain on at-risk and vulnerable families, women and children; creating illness, disease and even deaths and suicides.

One has to ask: IS THE CURE WORSE THAN THE DISEASE?

We could end the restrictions and lockdowns with the employment of EARLY outpatient treatment and prevention.

Use of QR codes, in my opinion, is an over reaching imposition and breach of privacy. Resources would be better used protecting and improving the health of vulnerable cohorts.

We have already seen security breaches of the stored information. Electronic surveillance and monitoring of our health data, travel, daily movements and activities is leading us down a dangerous path. No, I have nothing to hide, but I also do not want to become trapped in a biosecurity prison while someone profits from my data dust. A biosecurity state is not the Australia I want for my children and grandchildren.

NO to Vaccine Passports of any kind and/or Permanent Border Permits.

Again, c19 does not warrant this - it is very treatable; and vaccine passports will not make any one safer from sarscov2/c19.

Current covid vaccines are still experimental and unlicensed.

No long term safety data exists.

They are by no means risk-free.

They do not prevent infection or transmission - therefore an asymptomatic unvaccinated person poses no more risk than anyone else.

Many people will have natural immunity and not require vaccination.

Many will be advised not to have a second or even a first c19 vaccination.

Vaccination should be a personal medical choice, following fully informed consent.

I am therefore puzzled what the role of passports and border permits in protecting the community actually would be?

Medical apartheid must be opposed.

Supporting research and evidence for the claims made can happily be provided at your request.

I ask the Qld Government to please provide and make public, without redaction, all data, modelling and forecasts used by the Government in the decision-making process.

I also ask what is your view on these matters? Are you going to support this legislation? Or work for a better way to move forward for Queensland?
