**CALLING AN END TO THE EXTENSION OF STATE OF EMERGENCY  
POWERS BILL**

**Faith in both the BIG parties of Governments has completely failed.** There is NO STABILITY in anything the Government is proposing anymore and now the Government want to extend their Emergency Powers to 30 April 2022, to what we are being told is a pandemic.

**WHY HAS THIS NOT BEEN REPORTED IN THE MAIN STREAM MEDIA?**

The Government is the elected representative of the people, we pay their wages, and here they are trying to SNEAKILY pass a **secret bill in the middle of the Queensland Budgeting Sitting**, that is **NOT in the best interest of the Australian people**. Can I point out ***the World Health Organisation published data on 30/06/2021 which reported that only 2% of all global COVID-19 cases have ended in death***. **I AM CALLING FOR AN END TO THIS SECRET AUTHORITIAN  
STATE OF EMERGENCY POWERS BILL**

**1. NO** to ANY increased powers for Emergency Officers and Chief Health Officer to limit or respond to the spread of COVID 19 in Queensland, including issuing directions to require physical distancing, restriction of movement and gatherings, tracking, a person to quarantine or self-isolate and any other containment measures

**2. NO** to any authorised sharing of confidential information for contact tracing.

**3. NO** to encourage compliance with quarantine requirements, International and National border restriction and other health directions by providing fines or any form of penalties.

**4. NO** to an increased period for which regulation may extend a declared public health emergency

**5. NO** to ANY Bill that removes my hard-earned assets or personal belongings

**6. NO** to ANY form of restrictions that the Government want to impose on the people of Queensland

**7. NO** to forced vaccinations

**8. NO** to restriction of Religious Freedom
