- 1. You have been deceptive and have failed to consult the general public in order to introduce AND PASS the Bill, and this is evident and described in the bill itself:
- "Broader community consultation has not been possible given the need to ensure the amendments are introduced and passed before the expiry of the measures on 30 September 2021."
 - 2. You have never consulted the people in regard to quarantine. YOU ARE THE STATE! And as such, you have NO POWER to force quarantine. Section 51 (ix) give Legislative power ONLY to the Parliament. Chapter I, Part I, 1. Legislative Power, states: "The legislative power of the Commonwealth shall be vested in a Federal Parliament, which shall consist of the Queen, a Senate, and a House of Representatives, and which is hereinafter called *The Parliament*, or *The Parliament of the Commonwealth*."

3. You are inconsistent with the Federal Laws, which under Section 109 of the Constitution makes all things inconsistent INVALID. S.109: "When a law of a State is inconsistent with a law of the Commonwealth, the latter shall prevail, and the former shall, to the extent of the inconsistency, be invalid."

"The Bill is specific to the State of Queensland and is not uniform with legislation of the Commonwealth or another state or territory.
