*Legal Aid Queensland Act 1997***NOTIFICATION**

Legal Aid Queensland

Notice is hereby given that the Board of Legal Aid Queensland has determined changes to the policies and guidelines for the provision of legal assistance as follows:

1. Clarification of the expanded assets tests which applies to applications for legal assistance for domestic violence matters;
2. Expansion of available legal assistance to include representation at a dispute resolution conference for 'property settlement only' matters where applications meet the eligibility criteria;
3. Magistrates Court Pleas Guideline amended to specifically identify types of matters, being minor traffic prosecutions and regulatory offences, excluded from legal assistance;
4. Changing the grounds for availability of legal assistance for representation at Coronial Inquests by removing "the outcome of the inquest could potentially affect a substantial civil law claim" as a ground and adding "the applicant has in some way been involved in the death or deaths and may be criminally charged" as a ground;
5. Revising the Transfer of Solicitor Policy to have a single policy apply to all matter types;
6. Minor formatting, numbering and reference corrections in State Criminal Law Guideline 1, State Criminal Law Guideline 4, Commonwealth Civil Law Guideline 10, State Civil Law Guideline 1 – Child Protection.

The changes take effect from 1 November 2012.
