#### **GOVERNMENT QUESTION 1**

I refer to page 1 of Budget Paper 5 of the 2015-16 Queensland State Budget - Service Delivery Statements – Legislative Assembly of Queensland, and I ask Mr Speaker to kindly outline any steps he has taken to reduce costs and improve efficiencies in the Office of the Speaker since he has been elected as Speaker

#### SPEAKER'S RESPONSE

In terms of "reducing costs", I have reduced the staff establishment numbers within the Office from three (3) to two (2) staff establishment positions.

By abolishing the "Chief of staff and Executive Officer position" (an S03 position) a saving of approximately \$130,000 per annum has been achieved in 2015-16.

Further, rather than appoint external persons to fill the remaining two (2) vacant positions in the Office, I have seconded Parliamentary Service staff to work in the Office. This has two (2) benefits:

- a) Seconding experienced Parliamentary Service staff has made for a seamless transition because these staff have a good understanding of the Parliament, the Parliamentary precinct and the Parliamentary Service.
- b) Seconding these staff will also save on termination payments that would be payable when I cease to be Speaker (e.g. an officer engaged for one term of parliament would be eligible for 8 week's severance pay plus 1 months' notice).

I have also sought to reduce motor vehicle costs by extending the lease on the current vehicle provided to me. The current vehicle is in good condition and rather than simply replace it because it is due, I have asked for the lease to be extended which will save approximately \$4,500 per year compared to what the cost of a new lease would have been for a similar vehicle.

#### **NON-GOVERNMENT QUESTION 1**

With relation to page 3 of the SDS which states a "planned review will examine changes in security risks", can the Speaker provide a detailed schedule of events relating to the 2015 transfer of PCCC safes for each outgoing Member of the PCCC?

#### SPEAKER'S RESPONSE

The full context of the quoted statement from page 3 of the SDS is as follows:

"In 2015-16, the Parliamentary Service will conduct a comprehensive review of electorate office security. Building on the initial review conducted in 2007, the planned review will examine changes in security risks, security monitoring tools and techniques, and security awareness."

It is clear that the paragraph is referring to a review of electorate office security – predominantly the security of the physical environment and security systems.

The Parliamentary Service does provides various services to committees of the Legislative Assembly, including services to minimise security risks. In respect of the PCCC that includes the provision of two safes to each member of the committee for the secure storage of material at:

- (a) the Member's electorate office; and
- (b) the Member's office at Parliament House.

The Parliamentary Service, through Property Services, does arrange for the movement of the PCCC safes¹ when there are changes in membership on the PCCC. The PCCC at the appropriate time notifies Property Services from when to where the safes are to be moved and Property Services facilitates the movement of the safes. In respect of the movement of safes from one member's electorate office to another, Property Services often engages external contractors to facilitate the movement, particularly for electorate offices outside the South East corner. Safes outside of this area have always been moved by contractors.

It is stressed that when the safes are moved, they are moved without keys. That is, neither officers of Property Services nor any contractors engaged are able to open the safes.

Whilst strictly not relevant to the Finance and Administration Committee's examination of the appropriation for 2015-16, I am willing to provide some information about the process in early 2015.

Following the membership changes post the election and the appointment of new members, a request by the secretariat to move the safes was made to Property Services on 30 March 2015.<sup>2</sup>

In relation to the movement of the safes at Parliament House, the exact date that each of these safes were moved was not recorded. The safes were only moved after the permission of Members to enter and remove the safes were received. Some of the Parliament House safes were moved from a Member's office to the PCCC secretariat office for a period. One of the safes from Parliament House was moved to an electorate office.

All new Committee Members had safes in their Parliament House office by the time the Committee had its first meeting on 4 May 2015.

- (1) The proceedings of the Parliamentary Crime and Corruption Committee and the Ethics Committee or a subcommittee of those committees that is not open to the public or authorised to be published remains strictly confidential to the committee until the committee has reported those proceedings to the House or otherwise published the proceedings.
- (2) No member shall in the House refer to any proceedings of a committee in (1), until the committee has reported those proceedings to the House or otherwise published the proceedings.
- (3) A member who wishes to refer to in camera evidence or unpublished committee documents of a committee in (1) in a dissenting report shall advise the committee of the evidence or documents concerned, and all reasonable effort shall be made by the committee to reach agreement on the disclosure of the evidence or documents for that purpose.
- (4) A committee in (1) may elect for this Standing Order to not apply to a particular proceeding or a particular inquiry of the committee, and adopt its own rules in relation to the confidentiality of its proceedings for that proceeding or inquiry.

I emphasise that the issue relating to PCCC information and safes is currently before the PCCC and it is not appropriate for me to comment in respect of that matter. This question is also not relevant to the Finance and Administration Committee's examination of the appropriation for 2015-16.
