I am Utterly Opposed to Open Season on Qld Unborn

Abortion laws in Queensland are set to be the most barbaric in Australia and the World, if Labor's Termination of Pregnancy Bill 2018 is passed by state MPs.

Labor's Bill is proposing that various sections of the current Criminal Code be repealed, removing existing safeguards and scrutiny of abortions and allowing abortions to be performed for any reason and at any stage of pregnancy.

During the 2015 election campaign, both LNP and ALP pledged not to change abortion laws. Both major parties seem set to allow a conscience vote on the proposed legislation, thereby breaking their election commitments. If our MPs and Parliamentary advisors are truly concerned for the rights and protection of our states' children, they will not support a bill allowing unborn children to be murdered in the womb or out of the womb.

This monstrous ill-conceived legislation:

- Allows unborn children to be killed from conception right up to birth;
- Ignores the serious physical and psychological effects of abortion on women;
- Would coerce doctors, nurses and health workers into performing a barbaric procedure against their consciences;
- Dismisses overwhelming community opposition to changing the law;
- Fails to address the desperate plight of women who tragically see abortion as the only solution.

I believe that the seeking to legalise abortion on demand because a woman or couple might not be ready to be a parent is a poor argument for legalising abortion in Queensland.

"This bill is an unacceptable justification for such a permanent act."

It is well known that life begins at the moment of conception. The babe within the womb of the mother is a separate human life from the mother's life. Mother and child have a separate blood system and I believe, that the taking of life amounts to murder and this Termination Bill is aiding and abetting Murder.

"Medical science tells us that an unborn child already has all the characteristics and features of any human being, and my experience in the community has shown me that abortion has a lasting impact on the parents, and obviously fatal consequences for the unborn child."

The choice to abort, is usually taken in ignorance of the fact that from the moment of conception there is HUMAN LIFE; YES HUMAN LIFE! Labor's "TERMINATION OF PREGNANCY BILL 2018 is set to interfere with this and is only reflective of the FACT that People are perishing because of a lack of knowledge of the Truth and its responsibilities.
