 I filled out the online form twice, but wouldn't let me submit. Here my answers. Thank you.

[Also, I am willing to appear as a witness on 12 Sept in Brisbane, if needed. (Please note, I'm not particularly keen to speak in public. But if it saves even one baby's life, I'm happy to show up.)]

 1. **"Lawful Termination before 22 weeks" - Agree? - NO.**

Definitely NOT!!!! ABORTION is wrong at any gestation. END current abortion and facilitate ADOPTION instead!!!!

1 in 6 couples suffer INFERTILITY.
 1 in 4 pregnancies end in miscarriage.

My personal statistic is 3 pregnancies out of 4 lost to miscarriage. My heart is aching. Many thousands of hearts are aching to ADOPT a child!!!! Currently there are almost no babies to adopt because most of them get aborted. An 11 year waiting period for adoption is TOO LONG. 300 Babies terminated already each DAY in Australia already, is TOO MUCH.
