Dear : Committee

My name is Pastor Craig C. Ireland and I am writing a submission to be considered by the committee in its inquiry into aspects of the law governing termination of pregnancy in Queensland.

My submission is to respectfully request the committee to find pregnancy termination as abhorrent as God does as He has clearly stated in His Holy Word; the bible. Further to this, I request the committee to not only find the termination of pregnancy abhorrent, but to enact laws protecting life in the womb at all costs.

I recognise that there may be members of this committee who do not share my conviction that God's opinion matters in this discussion, and some might regard God's opinion not only irrelevant but utterly obsolete. Please allow me to disagree and show why.

God, being entirely holy and righteous, has in His Holy Word reinforced the value of all life, regardless of age, size, development or maturity, and has decreed it sinful and atrocious to illegally destroy life, especially the life of those people who are in the most innocent and vulnerable state, i.e. infants (pre-birth or otherwise).
