Re: Please reject/repeal proposed Abortion Law Reform- it is a criminal act against unborn children.

"Abortion Law Reform (Women's Right to Choose) Amendment Bill 2016 and Inquiry into laws governing termination of pregnancy in Queensland"

With regard to the Act itself and its "contents" (lack of) and the way it is being handled:

- The body of the entire proposed Act can be summed up in half a sentence. E.g. Section 224/ 225/226 "omit" and before S226 insert "repealed". I am accustomed to ready environmental legislation that is hundreds of pages long and into which much research has been done. <u>"Inquiry</u> into Laws governing termination" I do not see that any research or inquiry has gone into drafting this amendment law reform. I therefore consider this proposed Act, "a joke" drafted upon a whim. It is extreme laziness and demonstrated lack of due diligence to simply "press the delete key" four times to erase legislation, when thousands upon thousands of babies lives are at stake, plus the psychological and mental health of their mothers, fathers and extended family. The consequences are not considered and the potential consequences of doing so have not even been given a thought, and with no safeguards. why the law was there in the first place.
- If this case (proposed law reform) were being presented before court, I
 would expect that it would be "chucked out" of court for being in contempt
 of court, and for wasting the time of the courts. Also no opportunity for the
 Defence to present their case has been made, as can be evidenced in the
 Abortion Law Reform Act
- I also think it is an insult to the people of Queensland (and those that drafted the existing QLD laws) that they should be simply deleted, as if they did not exist before, and were not fulfilling any function. They are currently fulfilling a much needed function.
- To hurry legislation through Parliament, that should have been sent back to the drafting board numerous times before it could qualify as an "Act", is
- It is not the job of the Committee to undertake the research and medical/ psychological research for both the baby and the mother that should have been done prior to its submission. The MP's are not qualified doctors, and do not have experience with dealing the aftermath of abortion, they should

not be expected to be sudden experts. This places an unethical burden upon the busy MP's who also have families of their own. Extensive research needs to done prior to bills being presented.

Previously Queenslanders were told that they had a number of months to make submissions and write letters to their MP's. I see it as a perversion of justice, and democracy to have the timing to be brought forward to the end of the fiscal year. It would seem to be purposely timed so that that anyone that has any end of financial years matters to attend to (i.e. many employees, all small business owners, accountants, stock takers, heath insurance deadlines (for some health funds) cannot have any input. Also timing it (30 June) to when the nation is distracted with the election, so that community is unlikely to even notice that a Bill has come forward threatening the life of a large percentage of the next generation. This tells Queenslanders that something underhand is going on, that the public must wither be muted or distracted if the bill is to pass. We Queenslanders therefore ask for an extension of time, for justice sake.
