Once responsible for administering vaccines (including random/ad hoc, without records) like many of my peers I saw vaccine injury from the very early days, usually laughed at or dismissed by doctors. I was struck off the nursing register in 1986 for daring to report a doctor using unapproved drugs and vaccines randomly on Indigenous children in the northwest of WA.

Even though he was investigated, he went on to become an awarded doctor/leader in Indigenous medicine despite even elders questioning his methods (see Archie Kalokerinos' comment below). While I was reinstated it had become evident by then I could not make a real difference as a lowly nurse (as I was termed by this individual).

I studied 10 years in all, and was in private practice for over 20 years. Due to my outspoken efforts while working in research, I also received a black mark against my name and no longer am able to practice, despite the level of results achieved. In 1991 I was present at a WA hospital – all visitors had to sign waivers to not speak of what we were about to see; an auditorium full of vaccine injury from various palsies to tetraplegia to death (bereaved parents of previously healthy children).

My own personal situations should be enough, however it has been both professional and personal :

1. My own niece had previously suffered life-threatening effects of the DTP – thankfully I was on duty when she came in suffering respiratory arrest (see studies and notes below to explain this).
2. My nephew developed a form of juvenile cancer – admitted by the oncologist to have been caused by DNA damage to my brother through repeated vaccinations while in the Australian army. Like my own children, my siblings do not vaccinate. Most interestingly, the doctor followed up his comments with ‘But don’t quote me as I will deny it.’
3. I developed tumours over my entire body – from my neck to my arms, abdomen and legs. Doctors say they are not ‘yet’ malignant but will keep growing. The term is lipoma and can disfigure for life – with an increasing possibility they will become malignant with age. The only known cause is vaccine injury – namely BCG vaccine – which I was given 4 repeats of during my nursing career due to my apparent inability to develop a ‘natural’ immunity. Two family members had died of the effects of TB prior to this.
4. My son-in-law, despite being vaccinated for TB, was diagnosed with an advanced form. He had been given a grim prognosis and at one stage, being semi-comatose, losing all bodily functions, with cachexia leaving him nothing but skin and bone, with constant seizures, he was cured using natural therapies – after a leading HIV/TB doctor advised us that the vaccines and treatment had failed and agreed to us administering natural therapies in hospital. That doctor lost his job. However, my son-in-law was forced onto the standard treatment in order to meet immigration demands and died of an adverse reaction. My daughter, unvaccinated, had nursed him both at home and within the TB unit in Africa – she remains TB free despite our family history and despite being in contact with dead and dying for around 6 months.

I have seen such things many times in my career. IF people are to be vaccinated, they should be equipped with all the facts – meaning they must read all package inserts and research. If they are not educated, then it must be listed for them in point form. The simple fact is, no one is told the truth and only those who take the time to research understand the facts. Yet these are the ones who are punished – whether expert or laypeople.

People ask for proof and when it is provided it is flippantly dismissed without even taking time to read. And the truth is, most will not bother to read or even understand the facts. There are currently easily as many anti vaccine medical experts than there are pro vaccine. I have worked with them – and many no longer practice, having been hauled through trumped up charges and sensationalist media attack. Some have even died in mysterious circumstances. Why? It should be highlighted that Dr Sherri Tenpenny was banned from entering Australia – why? If all she is doing is talking facts surely she should be permitted to share her findings? That is not medical duty of care – that is a medical dictatorship.
