## To Whom it may concern,

I am sending a submission to communicate my diagreement with the proposed amendment that will exclude non vaccinated from child care services in Queensland and accept families go without their right to collect any assistance other law abiding citizens are privy to in this country.

The word "exclusion", in itself is unconstitutional and an illegal method to enforce any medication or medical procedure on any individual who is unwilling to give informed consent. To coerce any individual with the threat of monetary loss or exclusion from services in society because they exercise their legal right to reject a medical procedure, especially ones with known risks of injuries and death and varying questionable efficacy, is unconcionable, illegal and draconian in nature.

There is nothing that outweighs the cost to our civil liberties being taken away by allowing discrimination and coersion to conscientious and religious objectors. Certainly no claims made that vaccines protect against disease more often than they harm can be considered when not one blind placebo safety or efficacy study has been performed on a single vaccine. This proposed amendment violates the Nuremberg code of Medical Ethics and our human right to retain sovereignty over our own bodies and what we choose to put in them.

I am a mother of 10 healthy individuals whom I have raised free from vaccines. I made my decision to delay vaccines until I understood more about them. My decision not to vaccinate as I learned more abd more about vaccine safety and efficacy was not made out of fear of Autism as my journey started in 1996 before the report linking Autism to Leaky gut and the MMR report.

Not one of my children has any health issues of any kind. Not one of them have asthma, eczema, diabetes, allergies, cancer nor any other condition related to immuno deficiency that have been linked to the growing vaccine schedule. None have had any developmental issues physically, socially, behaviorally or mentally. If encephalopathy is a known side effect to vaccines, then it stands to reason that all sorts of mental and cognitive regression can be caused by vaccines. Millions of parents have reported immediate cognitive regression after vaccine induced febrile seizures. All of my children excel developmentally, academically and in sports, arts and/or culture and music. Very rarely do any of our household get ill. In 19 years we have not had more than chicken pox which left no lasting effect except long lasting possibly life time immunity and a mild case of influenza B, also fully recovering in less than a week. We were infected by a vaccinated individual in the case of chickenpox. Comparing the effects of childhood disease in Australia with effects of disease in the third world is both misleading and immoral.

"Severe measles is more likely among poorly nourished young children, especially those with insufficient vitamin A, or whose immune systems have been weakened by HIV/AIDS or other diseases. [..] As high as 10% of measles cases result

in death among populations with high levels of malnutrition and a lack of adequate health care. [...] More than 95% of measles deaths occur in countries with low per capita incomes and weak health infrastructures. [...] Overcrowding in residential camps greatly increases the risk of infection."

I believe the recent media campaign to launch this, "no vax no play no pay"...policy was driven by chanel 9 who's major share holders stand to profit through their financial association with GSK and therefore is a major conflict of interest as they stand to profit by increasing sales of vaccine drugs. It is little more than blatant drug advertising through a fear driven campaign.

All of the recent studies published in medical journals have concluded Dtap does not work. The pertussis component does not stop the spread to new borns most at risk of secondary illness after contracting the bacteria. The tetenus component does not protect the community as it is not a contageous disease, it is an extremely abundant toxoid which is present in every mamal's gut which in extremely rare cases presents as a dangerous condition in puncture wounds without oxygen exposure and proper wound care.
