

## **Public Health (Childcare Vaccination) and Other Legislation Amendment Bill 2015.**

The proposed changes in legislation, regarding unvaccinated children and childcare refusal, is the latest attempt by this government to usurp basic human rights. Parents have the right to make informed healthcare decisions for their children; this includes refusing vaccinations. The government has found that scare campaigns aimed at increasing vaccination rates have failed and are resorting to tactics of coercion via legislation.

In light of the recent revelations by CDC whistleblower Dr William Thompson it is shameful that governments anywhere are considering any type of backdoor compulsory vaccination laws. Dr Thompson has admitted that scientific fraud was committed at the CDC to cover up a link between the MMR vaccine and autism. He has turned over numerous documents to congressman Bill Posey. - The Hannah Poling case in the USA showed that vaccines can induce autism in children.
- The USA vaccination injury compensation scheme has paid out over three billion dollars in damages to vaccine victims.
- There is currently a court case against Merck for fraudulently manipulating the efficacy of the mumps vaccine.
- The HPV vaccine gardasil has damaged thousands of girls worldwide, resulting in legal action in some countries.
- The known contamination of the Rotavirus vaccines with the DNA of a pig virus
- The 10 nanograms of DNA contamination that is allowed in each vaccine. This could include chicken DNA, aborted Human foetal DNA ,depending on the cell substrate used to grow the vaccine.
- The recent outbreak of Mumps in Western Australia in fully vaccinated individuals.
- Whooping cough outbreaks in fully vaccinated schools.
- Complete refusal by all governments to conduct a study comparing the health outcomes of fully vaccinated versus unvaccinated children.
- A lack of safety studies on the ingredients used in vaccines, especially the aluminium adjuvants.

It is simply no longer tolerable that the government pretends that these issues do not exist. It is not acceptable that the government is trying to force parents to play vaccination roulette with the health of their children.

In the age of information ignorance is a choice. This government chooses to doggedly pursue maintaining the status quo on vaccination instead of honestly researching the numerous problems associated with the procedure. THIS IS NOT GOOD ENOUGH.
