Providing healthcare to babies born alive after an abortion is essential for several reasons.

- 1) the health of the newborn child,
- 2) the health of our healthcare professionals
- 3) the health of our society.

These most vulnerable members of our society desperately need the legislative protection of our government that allows (insists) that babies who survive abortions should receive the same excellent healthcare available to all Queenslanders. They are real people who have survived a determined attempt on their life.

If the government doesn't pabcd this legislation then we as a society are on a prescipice of callous disregard for human life that is barbaric but not new (the ancient Spartans used to leave their newborn unwanted babies to die on a heap outside the city). Where are we headed as a culture when the youngest in our society are denied basic health care?
