Submission for PUBLIC HEALTH AND OTHER LEGISLATION (COVID-19 MANAGEMENT) AMENDMENT BILL 2022

I agree with deactivating the emergency act, however, I disagree with "health" powers to be extended.

The implemented strategy did not meet its goals, and was a complete failure, that caused so many injuries at different levels.

Damage caused by "Health" department and the government strategy:

Early treatments were discouraged and suppressed, which lead to illnesses getting worsened. There was only one way to treat covid and it was the vaccine.
