To Whom It May Concern

I have several issues and/or with proposed PUBLIC HEALTH AND OTHER LEGISLATION (COVID-19 MANAGEMENT) AMENDMENT BILL 2022.

The fact that Ms D'Ath introduced is a significant concern. The people of Queensland have been repeatedly treated with contempt by her, the Qld Premier, and the numerous CHOs we have had since 2020. It is impossible for everyday Queenslanders to put any trust in her. She can't explain why there has been such an increase in cardiac issues across our state – her words... There has been no explanation as to why we are anticipating a massive increase in cancers across our state either. You would think a Health Minister would be able to produce that data easily.

I am concerned that Division 2 of the Bill uses phrases such as 'CHO's opinion' and 'if the CHO reasonably believes' are valid reasons to enforce ANYTHING on the people of Queensland. WHO gets to decide if the opinion is fair, reasonable and factual? I certainly hope it is not either the Premier or Ms D'Ath. They have not been able to 'keep their story straight' these past few years. We have been told repeatedly to 'trust the science' which subsequently changes to suit the upcoming footy grand finals, or Olympics planning meeting, or to further punish those Queenslanders who opted to wait until the current drug trial finishes NEXT YEAR, before participating.

I am concerned that there are 'Authorised officers' mentioned in Division 3 who will be able to march on into any non-residential premises, without a warrant; at minimal notice, and use 'force that is reasonable' (again – who determines this!?) to enforce compliance. This is overreach.

We must remember we are talking about what is essentially a nasty cold – which 99.something percent of people will survive, with minimal long-term side effects.

Studies and data are beginning to show that there is a greater chance of severe and longerterm side effects from having partaken in the 'vaccine' trial.

PLEASE tell me; WHEN in the history of our world have we demanded that children risk themselves for their elders? WHEN in the history of our work have older folk required children to be put at risk for their sake? Protecting our vulnerable should not come at the cost of intentionally causing harm to the strong. I may be misled in my concerns in a few areas but seeing as my repeated questions, emails, and concerns I have raised with Ms D'Ath, the Premier, and Queensland Health over the past couple of years have not been answered, (or have been responded to with the identical document sent to thousands of others) I have had to seek out and research these topics and issues for myself.

This Bill is not about health, it never was. If any of the Covid Management plans were, we would have been shown the data, been encouraged and trained in genuine basic health care procedures (we did not see anything along these lines from Qld Health until late in 2021), and encouraged to make decisions for ourselves and our families based on the vast array of transparent information we SHOULD have been provided with from early on.
