To the Secretary of the committee reviewing submissions on the above Bill.

I make the following submission in the hope it will be taken into account when Parliament considers the above Bill. My submission makes reference to headings in the Explanatory Notes attaching to the Bill as a nominal basis for detailing the issues to which I seek Parliament's attention:

Achievement of policy objectives

The Qld government's - health policy - objectives during 2020 were just plain wrong to begin with as they have crucified the economy, destroyed peoples lives, and created unnecessary fear of something that is treatable for most people who contract the disease. The government's actions during the last year are unprecedented in my life time - of more than three score and ten years - and I worry that young people, who have almost no morbidity issues with this disease will suffer a lifetime of mental trauma over an action done in their junior years by people who should have known better. Alternative ways of achieving policy objectives
