Subject: Submission to Parliament regarding COVID-19 situation

To whom it may concern,

We are writing to request the Queensland Parliament that it not extend the declared public health emergency in relation to COVID-19, with all the extraordinary powers granted to the Premier, the State Cabinet, the State Government, and the Queensland Chief Health Officer.

Instead, we would ask:

- That the Parliament immediately and entirely cancel the declared public health emergency in relation to COVID-19;
- That it revoke any extraordinary powers that have been granted to the Premier, the State Cabinet, the State Government, and the Queensland Chief Health Officer;
- That it unilaterally cancel any fines that have been dispensed for transgressing 'COVID-19-emergency' laws;
- That it give full refunds to those who have been involuntary incarcerated in mandatory hotel quarantine due to said 'COVID-19-emergency' laws;
- That it give an unequivocal apology to the people of Queensland, and Australia, for the trouble and destruction of life brought to this land in the Parliament's response to the COVID-19 virus;
- And that it submit to an independent and thorough enquiry into the Parliament's actions in all these matters.

There has been a utter lack of real accountability by the Queensland Government in this matters, and part of the problem is the lack of a House of review, or Senate, in Queensland. This ought to be remedied as soon as possible, the matter being put before the people of Queensland by way of referendum and enacted upon the approval of the people.

Most grievously, the Queensland Government, as a whole and in its members, has demonstrated a wilful ignorance of its rightful place in society, that is, under the One True and Living God, who has revealed Himself and His Law in the Holy Bible, and as servants to the people of Queensland.
