Re: Inquiry into the Tobacco and Other Smoking Products Amendment Bill 2023.

The Australian College of Nursing (ACN) would like to thank the Department of Justice for the opportunity to provide feedback on the **Inquiry into the Tobacco and Other Smoking Products Amendment Bill 2023.**

Please note we have distributed the consultation to ACN members for comment. Their responses have been taken into consideration and incorporated into the attached document.

As the national leader of the nursing profession, ACN supports and agrees with the introduction of new measures intended to lower smoking rates and improve health outcomes for all Australians while also reducing the burden of tobacco-related chronic diseases on the public health systems.

ACN would like to commend the Queensland Government and the Health and Environment Committee for taking human rights and their limitations into consideration as per the statement of compatibility for this Bill. ACN acknowledges that this legislation attempts to balance the freedom of all Queenslanders to be autonomous in decisions regarding their health (including the decision to purchase and use tobacco products) and preserve the right to a healthy environment and protection from harm caused by tobacco and smoking products.

ACN supports the amendments to the Tobacco and Other Smoking Products Amendment Bill 2023 and agrees with the amendments and principles listed. However, it is requested that the Queensland Government consider the following and request further clarification in further iterations of the Bill:

- Insertion of new section 11A (page 48)
- Insertion of new sections 52–52D (page 79)

Although ACN acknowledges the potential dangers of having minors vend tobacco products, ACN urges the Queensland government to contemplate the potential unintended consequences of this amendment. In particular, the consequences in relation to employment of minors. Therefore, ACN recommends that the Queensland government consider adding measures to protect the employment of young people who may be discriminated against when seeking employment due to



their age because of this amendment. These measures may include requesting that minors who are in an employment situation where they must serve tobacco products are required to undertake extensive training and monitoring or providing further guidelines and strategies for employers.

Additionally, ACN encourages the Queensland Government to provide further information regarding the regulatory framework surrounding the privacy and confidentiality of information. Regarding governance of information and how this information will be regulated and how any issues relating to privacy will be identified.
