Submission concerning the Voluntary Assisted Dying Bill 2021

I have addressed my feedback to the sections of the Bill which are of most concern to me.

Part 1, Division2, 5 Principles (d) 'every person approaching the end of life should be provided with high quality care and treatment, including palliative care, to minimise the person's suffering and maximize the person's quality of life'

I applaud the extra funding for palliative care as stated in paragraph 5, page 1 of the explanatory notes, and would like to see even more funding.

Part 1, Division4, 8 Voluntary assisted dying not suicide

- (a) Does not die by suicide
- (b) Is taken to have died from the disease, illness or medical condition mentioned in section 10(1)(a) from which the person suffered.

On page 2, paragraph 1 of the explanatory notes, 'under section311 of the Criminal Code, aiding or counselling another person to commit suicide is unlawful. Under section 300 of the Criminal Code, it is also a crime to unlawfully kill a person, whether or not the person consents'. This is the current legislation.

God has given us a moral standard to help us discern right from wrong. See the Ten Commandments at the end of this submission.

Just because other Australian states and other countries have assisted voluntary dying legislation, does not mean this legislation is actually good for our communities and society. This legislation may be seen as progressive thinking, but that does not mean what it contains is morally right. It is also not right to protect those people involved in implementing voluntary assisted dying, from liability for doing what is wrong, committing murder, (Part10, 147 to 150).

It is wrong for people to be given a substance to kill themselves or to request another person to administer the substance. It is murder. See the Ten Commandments at the end

of this submission. God created each of us for a purpose. He decides when we are to be born and when we are to die. It is not for us to decide when we are to die.

We will all stand before the judgement seat of God and each of us will give an account of ourselves to God (Romans14: 10b &12)

Has any consideration been given to the mental health of those workers who will be involved in implementing voluntary assisted dying? Are they likely to be at a higher risk of committing suicide themselves than the general public?

Part 4, Division4, 81 Cause of death certificate

- 3 The medical practioner -
 - (a) Must state in the cause of death certificate for the person that the cause of death of the person was the disease, illness or medical condition mentioned in section 10(1)(a) from which the person suffered, and
 - (b) Must not include any reference t voluntary assisted dying in the cause of death certificate for the person.

This is not truthful. It is wrong to encourage people to lie. Both the disease etc and the voluntary assisted dying must be included on the death certificate.

Part6, division1, conscientious objection, 84 and 85

The health practitioners and speech pathologists with conscientious objection to voluntary assisted dying should not be forced to refer people onto services which are involved with voluntary assisted dying. It is up to the person wanting voluntary assisted dying to find out through other sources.

In conclusion, I strongly recommend substantial increase in funding and implementing of effective palliative care services which can be easily accessed by all people in Queensland, including rural and remote areas. The funds spent would provide benefit to many more people than the funds spent on voluntary assisted dying. Voluntary assisted dying is murder in God's eyes. We are all accountable to God for our actions.
