## Submission to Qld Parliamentary Committee into improving Queensland's Container Scheme Refund

The Rotary Club of Kenmore Inc (**KRC**) registered for a Container ID when the Scheme initially commenced. Our intention in doing so was that our involvement with the Scheme would be one of our Community Projects intended to reduce landfill or litter in our Club area and by redeeming 10cents for every eligible container would provide income to be used by the Club for the local community including assisting with making youth in schools in our area and /or involved in our projects aware of how they or their parents may assist their schools by redeeming containers and what is involved with them obtaining the necessary scheme ID if they wish to participate in the Scheme.

Initially the Club had 2 cages manufactured which were placed at E-waste in Kenmore Hills and Pullenvale Marketplace in Pullenvale as donation points where members and the public that wished to donate their containers to KRC could deposit them.

A member of KRC at that time arranged collections from these 2 points and looked for other sites and commenced negotiations with a representative from ReturnIt about possibly collecting from a site or sites in the area instead of our members taking containers to depots outside the area. At the time of commencement there was no depot in the Western Suburbs. The closest depots to Kenmore we ascertained were Tomra (Seventeen Mile Rocks) and Newmarket (ReturnIt).

Our local State MP Dr Christian Rowan arranged for KRC to apply for a Department of Environment Grant which we were successful in obtaining and enabled us to purchase a trailer, purple bins and arrange for some advertising signs to promote our involvement in the scheme sign and expand our sites for donation points to include:

- Our Lady of the Rosary Catholic Church Kenmore;
- St Catherine's Church Moggill;
- Anglican Church Kenmore; and
- a member's house in



When the scheme started and even today currently in the area rthere are no depots of Coex contractors in the State electorates of Mawar and Moggill. We do not know why this is the case but Ken being a retired town planner and Michael a retired lawyer believe land with suitable zoning f0 a depot may not be available for Coex or one of their contractors to purchase or lease in the area. This means that apart from bag drops there are Reverse Vending Machine in Moggill Shopping Centre car park and Indooroopilly Centre and according to the Coex website Circulis will be installing Reverse Vending Machines in the 2 Kenmore Shopping Centres.


Ken and Michael fulfilled the grant from the Environment Department during the closure and recommenced collections in June 2020.

Ken and Michael continue today as project managers of the Containers for Change collections on behalf of KRC are the persons making this submission on behalf of KRC and are authorized by KRC to do so.

Subsequently over time KRC has expanded our donation points to include:

- a tree lopper's property at Brookfield (where bins were placed within property so they could drop containers they used in their business and outside property for local community);
- a block of units at Merlin Terrace Kenmore; and a café on Brookfield Rd, Kenmore.

We share proceeds from OLR Church and St Catherine's donation points with Our Lady of the Rosary Catholic Parish Kenmore Moggill. Below is a copy of media article OLR published on what they used their proceeds for in first year. E-waste use their share for assisting with their operations at Kenmore Hills, Yeronga and Ipswich to assist youth as part of their training programme through NDIS.



One of KRC's projects that funds are used for is a Youth Leadership program at Kenmore State High School.

Funds were also used to install a defibrillator at Pullenvale Marketplace.

Following KRC recommencing after the Covid break and Dr Rowan facilitating various meetings at his office with representatives of Coex we were introduced by Coex to Community Co Recycling Pty Ltd an operator who has partnered 'with us to service Brisbane's Western Suburbs since 2021 when they arranged for pods to be placed at St Catherine's Moggill initially and then OLR Kenmore. The photo below was taken shortly after St Catherine's pod was installed.

In 2024 we arranged for the Coex Regional Manager Brisbane and Partnerships Lead Charity and Community Groups to undertake a tour of all our sites in March 2024 and they prepared an action list but despite follow up we never received:

- during Covid after a contractor they had been using withdrew from Scheme and we introduced him to Community Co and they had several meetings with him or staff the asked to meet with them and we were told from both sides that the school wouldn't do anything if students didn't pick it up and run with it. Nothing had happened and as our involvement was to introduce the parties so containers could be recycled we weren't seeking to take any cash away from school and we haven't followed up. As the Regional Manager suggested they could arrange for their School Lead to visit we provided contact names but never heard if this occurred.
- Kenmore State School through KRC's involvement with a program called Solar Buddy Ken and Michael were introduced to because we believe they obtained an ID and participate in te scheme we suggested to the Regional Manager he have the Coex school Lead contact her direct as again Rotary are seeing this as an opportunity for school to raise funds.
- Chapel Hill State School is a school we undertake Rotary Junior Community awards with every year and Ken did speak with principal is who knows Kenmore Rotary well and we provided his contact details so Coex could contact directly, we do not know if this occurred.
- We were asked by a member of the P&C at Brookfield State School who had obtained a scheme ID for school to give her guidance in what she needed to become operational, and we put her on to locations where we purchased bins etc. early on and subsequently introduced her to Community Co who used to go to school after collecting from Ewaste. We indicated to the Regional Manager we understood they are part of the Coex Wave for Change.
- Adjacent to our Moggill Pod Tomra installed at the Moggill Shopping Centre a Reverse Vending Machine which competes with our bag drop. WE asked the Regional Manager during his visit of our sites would 2 sites be so close and we were told not usually. It was suggested Coex would ask Tomra if we could be their charity for that site but we never heard anymore about that from Coex.



Since commencing our collections and up till 4 September 2024 KRC has save 537,085 containers from going to landfill in our area and along with its partners received \$153,708.50. In financial year 2023-2024 KRC was advised by Coex we had collected during that financial year 117,487 containers broken down as follows:

We will endeavour to explore with Coex with support and assistance from . how we can continue to collect large numbers of containers in our area and share receipts with partners while recognizing that it is likely some members of the public who don't want to stand and use a reverse vending machine for a couple of hundred containers may be forced to visit depots a long way from home.
