TO WHOME IT MAY CONCERN,

I AM RAYMOND PROWD MY WIFE BROKE HER LEG ON THE 9TH JANUARY 2005, SHE ALSO HAD EMPHYSEMA, SHE PASSED AWAY ON THE 25TH JANUARY 2005.

I WAS WITNESSED TO TWO EPISODES IN [REDACTED] AND WAS LIED TO BY A SELF APPOINTED CHIEF SURGEON, WHICH GAVE ME DOUBT'S AS TO WHY MY WIFE DIED. I RECEIVED THE 1ST OF 5 DEATH CERTIFICATES 8 DAYS AFTER SHE DIED STATING ONLY CHRONIC OBSTRUCTIVE AIRWAY DISEASE.

I APPLIED TO THE THEN QUEENSLAND HEALTH RIGHTS COMMISSION AND THE CRIME AND MISCONDUCT COMMISSION TO GET AN INVESTIGATION.

I RECEIVED A CALL FROM Q&H HEALTH ON THE 9TH JANUARY 2006 AND WAS TOLD THEY WOULD INVESTIGATE MY WIFE'S DEATH.

ELEVEN MONTHS LATER I WAS STILL BEING TOLD THE INVESTIGATION WAS PROGRESSING, THAT THE HOSPITAL RECORDS WERE BEING GIVEN TO A SPECIALIST FOR THEIR ASSESSMENT OF WHAT HAD CAUSED HER DEATH. ON THE 5TH DECEMBER 2006 I RECEIVED A CALL WHICH INFORMED ME THAT THE PERSON INVESTIGATING MY CASE HAD GONE ON HOLIDAY'S AND ANOTHER PERSON HAD TAKEN OVER FROM HER, HE INFORMED ME (ONCE AGAIN) THAT THE REPORTS WOULD BE HANDLED TO A SPECIALIST IN THE NEXT FEW DAYS FOR THEIR ASSESSMENT. AS I HAD BEEN TOLD THIS MANY TIMES I INFORMED HIM THAT IN MY OPINION ONCE AGAIN I WAS BEING LIED TO.

I CONTACTED THE COURIER MAIL PAPER, WITHIN 4 DAYS OF PUBLICATION I RECEIVED A REPORT (WHICH I HAVE ENCLOSED).

I WAS NOT PLEASED BY THIS REPORT AND TRIED TO RING TO VOICE MY OBJECTIONS. NO REPLY. I THEN PROCEEDED TO WRITE MY REPLY ON THIS REPORT WITH MY OPINION OF IT, AND WHAT I THOUGHT OF THE NOW QUEENSLAND QUALITY AND COMPLAINTS COMMISSION (QUALITY RUBBISH). I FAXED IT BACK TO THEM, I RECEIVED A CALL WITHIN MINUTES BY THE AUTHOR OF THIS REPORT SHE WAS OFFENDED BY MY COMMENTS. I ASKED WHY THIS REPORT WAS DONE BY A VASCULAR SURGEON AND NOT A RESPIRATORY SPECIALIST AS MY WIFE

HAD A LUNG PROBLEM, NOT VARICOSE VEINS. SHE INFORMED ME THEY
COULD NOT GET A RESPIRATORY SPECIALIST TO DO A REPORT. I INFORMED
HER THAT IN MY OPINION SHE COULD NOT GET A RESPIRATORY SPECIALIST
TO WRITE WHAT THEY WANTED HIM TO, SHE STATED SHE WAS
OFFENDED BY MY ~~REMARKS~~ I SAID IT WAS NOT AN ~~ACCUSATION~~ BUT
AN ACCUSATION AND IN MY OPINION SHE WAS LYING

I THEN RANG AND ASKED FOR FREEDOM OF INFORMATION FORMS
I REQUESTED ALL TRANSCRIPTS OF INTERVIEWS AND ANY OTHER WORK
RELATIVE TO THIS INVESTIGATION (I KNOW I HAD NOT BEEN INTERVIEWED) 4 DAYS
AFTER POSTING THESE FORMS, I RECEIVED A CALL FROM A ~~PERSON~~
WHO STATED THAT SHE COULD NOT RELEASE ANYTHING TO ME AS THERE
HAS BEEN NO INVESTIGATION AT ALL, I HAD NO CHOICE BUT TO
CANCEL MY FREEDOM OF INFORMATION APPLICATION.

IN OTHER WORDS QLD QUALITY AND COMPLAINTS HAD BEEN LYING TO
ME FOR THE LAST 12 MONTHS AND IT WOULD SEEM THERE WAS NO
INTENTION OF EVER DOING AN INVESTIGATION.

REMEMBER I RECEIVED A REPORT DATED 12TH DECEMBER 2006
AT LAST I RECEIVED A CALL FROM CRIME AND MISCONDUCT WHO
STATED THAT THEY HAD JUST OPENED QLD QUALITY AND COMPLAINTS
TO DO AN INVESTIGATION, I ASKED WHY GIVE THESE LYING IDIOTS A
JOB THEY HAD ALREADY BEINGLED.

IN DUE COURSE TWO INVESTIGATORS CAME TO INTERVIEW ME AT MY
HOME, HER 1ST REMARK THAT MY COMPLAINT FILE HAD NOT BEEN CLOSED
I INFORMED THEM THAT I WOULD TAKE NO MORE LIES AND TO GET
IN THERE CAR AND LEAVE, I PRODUCED THE REPORT THAT STATED
MY FILE HAD BEEN CLOSED, THEN THE INTERVIEW WENT AHEAD.

ON THE 14TH MAY I RECEIVED A CALL STATING THAT THE INVESTIGATION
HAD BEEN COMPLETED AND IN A FEW WEEKS I WOULD RECEIVE A REPORT
10 WEEKS LATER I RANG CRIME AND MISCONDUCT TO GET THIS REPORT
THEY RANG BACK AND TOLD ME THAT IN 10 WEEKS THE REPORT WAS
ONLY HALF COMPLETED AND ~~THEY~~ QUEENSLAND QUALITY AND COMPLAINTS
REQUESTED ANOTHER 6 WEEKS TO COMPLETE IT

I COULD WRITE A NOVEL IN 16 WEEKS

THROUGHOUT ALL THIS I HAVE TRIED TO GET EXTRA NEWS
I CONTACTED

HE SENT ME A MEMO

11 MONTHS AFTER I CONTACTED HIM (A BIT LATE)

~~THE~~ ^{RESPONSE} MORE ~~FROM~~ FROM SANTA CAUSA

THE HEALTH MINISTER, HE INFORMED ME HE DID NOT HAVE
SPACE IN HIS DIARY, SUGGESTED HE GET A BIGGER DIARY

BROKE HER LEG AT HOME, AND DIED IN A HOSPITAL THERE SHOULD
