I wish to lodge a formal submission regarding the Illegal Operation of Uber. who is an Overseas Company operating within Australia as a passenger hire business without the necessary LICENCE.or EQUIPMENT to ensure passenger safety. Uber does not adhere to any of the laws which this state have set in place to assure a safe, efficient, regular 24 hour service for the public. Not to mention their lack of provision for the Disabled. Government set in place a fare structure to ensure the public were protected and this is increased by our Government after a survey as to viability. However, this does not apply where Uber is concerned. When a person needs a cab most they can be charged anything up to 3 or 4 times the cost of a Taxi fare.
